NOTIFICATION

Whereas, it was decided on the 12th day of June, 1989 that the number of IMFL shops should be frozen at the then existing level in all the four regions of Union Territory and the grant of new licences were banned, subject to the condition that the ban is relaxable in respect of *bona fide* hotels and such other Institutions for promoting tourism;

2. And whereas, in pursuance of the above decision, no fresh licence was issued to any private individual since 1989, however, in relaxation of the ban, fresh IMFL licences had been granted for tourism category hotels and restaurants from the year 1989 onwards;

- 3. And whereas, M/s. Indian Coast Guard Station, Karaikal, has requested for grant of a fresh FL.1. Wholesale licence to run a Unit Run Canteen at Indian Coast Guard Station, Karaikal, for import and sale of liquor to ex-servicemen residing in and around Karaikal District;
- 4. And whereas, considering the merits of the request, the Council of Ministers has accorded approval to grant a fresh FL. l. Wholesale licence to run a Unit Run Canteen at Indian Coast Guard Station, Karaikal, for import and sale of liquor to ex-servicemen residing in and around Karaikal District;
- 5. Now, therefore, the sanction of the Lieutenant-Governor, Puducherry, is hereby conveyed for the grant of a fresh FL. 1. Wholesale licence to run a Unit Run Canteen at Indian Coast Guard Station, Karaikal, on payment of licence fee at the rate of 1% of the sum of fees payable under sub-rules (a) and (b) of rule 118 of the Puducherry Excise Rules, 1970, for import and sale of liquor to ex-servicemen, under the provisions of the Puducherry Excise Act, 1970 and the rules made thereunder.
