NOTIFICATION

Whereas, the management of M/s. The Cinema Providence, Providence Mall, Puducherry, has applied for grant of exemption from certain provisions of the Puducherry Shops and Establishments Act, 1964, to conduct special morning shows on account of screening new films;

And whereas, the Lieutenant-Governor, Puducherry, has by Notification in G.O. Ms. No. 9/95/Lab., dated 07-04-1995 under sub-section (1) of section 52 of the Puducherry Shops and Establishments Act, 1964, authorized the Secretary to Government, Labour Department, Puducherry, to exercise the powers of the Government under section 6 of the said Act, relating to exemption;

The conduct of the special shows shall be subject to the following conditions:

1. Every person employed shall be paid overtime wages for the period of work done by him in excess of 8 hours in a week.

2. The persons employed shall be given rest interval of atleast half-an-hour for every four hours of work.

3. The management should obtain permission from the authorities concerned wherever necessary.

4. In case, the said screening of the new film does not take place, this notification shall have no effect.

5. The SOPs issued in respect of COVID 19 like wearing of mask and other conditions issued by the Department of Revenue and Disaster Management Puducherry, shall be strictly adhered to.

Whereas, the Government of Puducherry vide G.O. Rt. The party raising the dispute shall file a statement of claim complete with relevant documents, list of reliance and witnesses to the Labour Court, Puducherry, within 15 days of the receipt of the order of reference and also forward a copy of such statement to each one of the opposite parties involved in the dispute.
