It is also stated that you have become a source of terror among the public. As a result, the people of the locality being afraid of you and do not come forward to lodge any complaint against you. It is also stated that even witnesses don't come forward voluntarily to give evidence against you in the cases where you are the accused;

And whereas, the Station House Officer, Bahour Police Station, Puducherry, further submitted that if, you are allowed to reside in Subdivisional Magistrate (South) jurisdiction limits, it is apprehended that you would continue to indulge in serious offences like assault, rioting, criminal intimidation, obstructions, annoyance and disturbance to the public tranquility and order, *etc.*, and thereby emerge as a perennial source of threat to the community and disturb public peace and order;

And whereas, summons were served for your appearance on 16-05-2022, 20-06-2022 to file your explanation/objection as to why the Subdivisional Magistrate (South), Villianur should not order to prevent you from entering into the south region under section 144(3) of Cr.P.C. and you failed to appear before this Court and hence, the case is decided *ex parte* under section 144(2) of Cr.P.C. in the view of urgency of the matter;

And whereas, based on the report laid before me, I am of the opinion that if, you are allowed to reside within the limits of this jurisdiction, you will continue to indulge in and also motivate serious offences and disturbance to the public tranquility and order, *etc.*, and thereby become a perennial source of threat

to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C., is invoked to take action against you to prevent harm to life and properties of citizens and uphold public peace and order; your presence is a threat to public tranquility in Puducherry District and therefore, an immediate action is required for curtailing your illegal activities in the locality;
