1	Consultation	With stakeholders of the proposed area including Thirunallar Commune Panchayat.
2	Survey (organization)	Tahsildar, Taluk Office, Thirunallar/The Assistant Director of Survey will complete the survey of proposed area under acquisition within 15 days from the date of publication of this notification.
3	Public hearing(s)	The Social Impact Assessment (S.I.A) Unit will decide the time and place for public hearing before submitting Social Impact Assessment (S.I.A) report.
4	Time-line	The Social Impact Assessment (S.I.A) Team shall commence the study within thirty days from the issue of this Notification. The Social Impact Assessment (S.I.A) report and Social Impact Assessment Management Plan (S.I.A.M.P) to be completed within two months from the date of commencement of study and published on the notice-board of the concerned offices/authorities.

7. The Social Impact Assessment Team shall submit its report in Form-III, as per rule 7(4) of the Puducherry Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Rules, 2016, within a period of two months from the date of its commencement.

8. Any attempt of coercion or threat during this period will render the exercise *null and void*.
