Government Higher Secondary School, Kottucherry, Karaikal, under the control of the Deputy Director (Secondary Education) Karaikal, from the authorized e-waste collection centre/recycler/dismantler (valid licence holders) in "as-is-where-is" condition.

- 2. The tenders in sealed covers should be addressed to the Office of the Vice-Principal, V.O.C. Government Higher Secondary School, Kottucherry, Karaikal, duly superscribed on the envelope as "Tender for e-waste materials" and to reach the undersigned on or before 06-06-2022. The tenders will be opened on the same day at 11.30 a.m. in the presence of the tenderers or their authorized representatives who are present at the time of opening of tenders. If, the tender opening date happens to be public holiday, the same will be opened on the next working day. The incomplete tender is liable for rejection.
- 3. The tenderer(s) should offer rate per kilogram in the tender. The sale will be effected only to the highest rate quated tenders. Public auction will be started from the highest rate quoted by the tenderers.
- 4. Tenders received after the due date and time will summarily be rejected. In the public auction, the tenderers who have submitted sealed tenders only will be allowed to participate.
- 5. The tenderers should deposit an amount of ₹ 1,000 (Rupees one thousand only) as earnest money deposit by cash.
- 6. The earnest money deposit of the unsuccessful tenderers/bidders will be refunded after the tender/auction sale is completed/ finalized.
