NOTIFICATION

The Lieutenant-Governor, Puducherry, is pleased to enhance the quantum of financial assistance from ₹ 75,000 to ₹ 1,00,000 for performance of marriage of Poor Scheduled Castes/Scheduled Tribes brides and for said purpose hereby makes further Amendments to "Government of Puducherry, Grant of Financial Assistance for Performance of Marriage of Poor Scheduled Caste Brides" notified vide G.O. Ms. No. 51/91-Wel. (SCW-I), dated 15th November 1991 of the Chief Secretariat (Welfare and Transport), Puducherry and published in the Gazette of Puducherry, Extraordinary Part-II, No. 21, dated 21st November, 1991 (hereinafter referred to as the said rules), namely:-

## AMENDMENT

In the said rules :-

(i) In rule 1 (1) and (2), the following shall be substituted, namely:-

- (1) These rules may be called “The Government of Puducherry, Grant of Financial assistance for performance of Marriage of Poor Scheduled Castes/Scheduled Tribes Brides (Amendment), Rules, 2022”.
- (2) They shall come into force on the date of their publication in the Official Gazette.

(ii) In rule 4, for the words, figures and brackets “₹ 75,000 (Rupees seventy-five thousand only)”, the words, figures and brackets “₹ 1,00,000 (Rupees one lakh only)” shall be substituted.

(iii) In Form No. VI prescribed under sub-rule (5) of rule 5, for the words, figures and brackets “₹ 75,000 (Rupees seventy-five thousand only)”, the words, figures and brackets “₹ 1,00,000 (Rupees one lakh only)” shall be substituted.
