The sealed tenders should be addressed to the Chief Educational Officer, Mahe, duly superscripted on the envelope as "Tender for the purchase of old newspapers and magazines" and to reach the undersigned on or before on 13-12-2022 at 11.00 a.m. The tenders will be opened at 12.00 noon on the same day in the presence of the tenderers who are present in the Office of the Chief Educational Officer, Mahe.

3. The intending tenderers should deposit an amount of ₹ 300 (Rupees three hundred only) as earnest money deposit in cash and it will be refunded to the unsuccessful tenderers, after the acceptance of the highest tender/finalization of the tender. Tenders without the abovesaid earnest money deposit will not be taken into consideration.

4. Tenders received after the due date and time will be rejected.

5. The successful tenderer should pay the full amount immediately as and when call made and clear the old items within 2 days at his/her own risk and cost, failing which, the earnest money deposit will be forfeited.

6. The intending tenderers can inspect the articles during the office hours on all working days. The rate should be quoted per kilogram.

7. The successful tenderer should make his/her own arrangement for weighing the articles.

8. GST will be collected extra as per the rate applicable.

9. No claim on the quantity and quality of the articles will be admitted once the tender is finalized.

10. The undersigned reserves the right to accept or reject any tender without assigning any reason thereof.
