ORDER

(UNDER SECTION 144 OF Cr.P.C.)

To

Whereas, it has been made to appear to me that you have trivial and scant respect to the judiciary and rule of law and are involved in various offences against public tranquility, offences affecting property and human body and that you have become a perennial source of threat to the community, public peace and order;

And whereas, I am convinced of your involvement in various criminal cases under –

1. Cr.No. 211/2014 under sections 324, 427, 506(ii) IPC r/w 34 IPC of Villianur Police Station, Puducherry – Pending Trial.
2. Cr.No. 245/18 under sections 294(b), 324, 506(ii) r/w 34 IPC of Villianur Police Station, Puducherry – Pending Trial.
3. Cr.No. 441/2020 under sections 147, 148, 341, 302 IPC, section 3(2)(V) of SC and ST (POA) Act, 1989, section 4(i)(V)(S) of SC and ST (POA) Amendment Act, 2015, r/w 149 IPC of Villianur Police Station, Puducherry – Pending Trial.

and your vengeful acts along with your accomplices against your opponents have created panic in the minds of the people;

And whereas, the Station House Officer, Villianur Police Station, Puduchery, has filed a case against you *vide* IR.No. 09/2022 under section 144 of Cr.P.C., dated 19-05-2022. It is stated by the Station House Officer, Villianur Police Station, Puducherry, that you are indulging in crime such as hurt, robbery, Arms Act, intimidation, rioting and disturbance to the public tranquility and order and you have created panic in the minds of local inhabitants. It is also stated that you have become a source of terror among the public. As a result, the people of the locality being afraid of you and are not coming forward to lodge any complaint against you. It is also stated that even witnesses don't come forward voluntarily to give evidence against you in the cases where you are the accused;

And whereas, the Station House Officer, Villianur Police Station, Puducherry, further submitted that if, you are allowed to reside in the South Subdivision limits, it is apprehended that you would continue to indulge in serious offences like murder, extortion, damages to public and private properties, assault, obstructions, annoyance and disturbance to the public tranquility and order, *etc.*, and thereby emerging as a source of threat to the community and may disturb public peace and order;

And whereas, summons were served for your appearance on 20-06-2022, 04-07-2022, 18-07-2022, 22-08-2022, 12-09-2022 and 28-09-2022 to file your explanation/objection as to why the Subdivisional Magistrate (South), Villianur, should not order to prevent you from entering into the south region under section 144 (3) of Cr.P.C., but, you are failed to appear before this Court and hence, the case is decided *ex parte* under section 144(2) of Cr.P.C., in the view of urgency of the matter;

And whereas, based on the report laid before me, I am of the opinion that if, you are allowed to reside within the limits of this jurisdiction, you will continue to indulge in and also motivate serious offences and disturbance to the public tranquility and order, *etc.*, and thereby becoming a source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C., is being invoked to take action against you to prevent harm to life and properties of citizens and uphold public peace and order and therefore, an immediate action is required for curtailing your illegal activities in the locality;

Now, therefore, based on the reasons stated above, I, K.Muralidharan, Subdivisional Magistrate (South), Puducherry, in exercise of powers conferred under Code of Criminal Procedure, 1973, do hereby prohibit you under section 144 of Cr.P.C., from entering into the South Subdivision, Puducherry, for two months from the date of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry.
