NOTIFICATION

The Government has constituted the State Level Committee on Standardization and Quality Systems under the Chairmanship of Chief Secretary, Government of Puducherry, for a period of 3 (three) years from the date of publication of this order.

2. In G.O. Ms. No. 12/2006-Ind.A, dated 03-11-2006 of the Under Secretary to Government, Department of Industrial Development (Industries and Commerce), Puducherry, the Government of India has requested the Union Territory Government to Constitute State Level Committee on Standardization (SLCS) with the composition and Terms of Reference given therein.

3. The Government, after careful consideration, has decided to reconstitute the State Level Committee on Standardization (SLCS) with the following composition and Terms of Reference with a view to promote the use of Indian Standards as a means to creating a robust Quality Ecosystem and protecting the interests of the consumers in the formulation and use of Standards:-

Composition

1. Chief Secretary to Government, Puducherry. . . Chairperson
2. Secretary to Government (Civil Supplies and Consumer Affairs). . . Member-Secretary.
3. Secretary to Government (Industries and Commerce) . . . Member
4. Secretary to Government (Legal Metrology) . . . Member
5. Secretary, Chamber of Commerce and Industries (SICCI). . . Member
6. Chairman, Confederation of Indian Industry, Puducherry. . . Member
7. Chairman, Federation of Indian Chamber of Commerce and Industries, Puducherry. . . Member
8. Representatives of two Consumer Organisations/ NGOs in the State. . . Member
 - (i) Thiru G. Krishnaraj, Pondicherry Consumer Association Federation, Puducherry.
 - (ii) Thiru R. Hariharinamonarayana – Indian Consumer Welfare Council, Puducherry.
9. Chairman, Indian Institute of Public Administration, Puducherry. . . Member
10. General Manager, Indian Oil Corporation plant, Villianur, Puducherry. . . Member
11. The Managing Director, Spinco, Puducherry. . . Member
12. Vice-Chancellor, Pondicherry University, Puducherry. . . Member
13. Vice-Chancellor, Puducherry Technological University, Puducherry. . . Member
14. Deputy Director-General, Southern Region, Bureau of Indian Standards, Chennai. . . Member

Terms of Reference

- (a) Identifying areas for the formulation of new Indian Standards.
- (b) Identifying Products, processes and systems for enforcing compliance with Indian Standards.
- (c) Measures for effective implementation of Quality Control Orders (QCOs) issued by Government of India.
- (d) Measures for awareness generation among consumers regarding Standards.
- (e) Any other activity to create a robust Quality Eco-System in the State.
- (f) The Representatives of Non-Government Bodies shall be nominated by the Chairperson of the State Level Committee on Standardization (SLCS) and the term of their engagement will be 3 (three) years. They can, however, be renominated.

- (g) The Committee shall meet at least twice a year and as many more time, as deemed fit by the Chairperson.
- (h) Heads of the Bureau of Indian Standards (BIS), Branch Offices in the State shall provide necessary support to the Member-Secretary to convene the meetings and take follow-up action on the decisions taken in them. Head of the Bureau of Indian Standards (BIS), Branch Office located at Chennai, Branch Office-I shall be the Nodal Branch Office for this purpose.

4. The Department of Civil Supplies and Consumer Affairs shall Co-ordinate and follow up for taking necessary action by all Members of the State Level Committee on Standardization (SLCS) to carry on the functions specified in the terms of reference.
