NOTIFICATION

In exercise of powers conferred by sub-section (5) of section 68 and section 96 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Lieutenant-Governor, Puducherry, hereby makes the following Amendment to the Puducherry Motor Vehicles Rules, 1989, the Draft of the same have been pre-published in the Notification issued in G.O. Ms. No. 07/Tr.Sectt/2022, dated 3rd August, 2022 by the Transport Department (Secretariat Wing), Puducherry and published in the Extraordinary Gazette Part-II, No. 37, dated 12th August, 2022 as required under sub-section (1) of section 212 of the said Act and no objections and suggestions having been received in response thereto by the Department, namely:-

AMENDMENT

1. Short title and commencement.— (1) These rules may be called as the Puducherry Motor Vehicles (Amendment) Rules, 2022.

(2) They shall come into force on and from the date of their publication in the Official Gazette.

2. Amendment of rule 62.— In the Puducherry Motor Vehicles Rules, 1989, in rule 62, after sub-rule (2), the following sub-rule (3) shall be inserted, namely:-

“(3) It shall be lawful for the State Transport Undertaking to operate on any route as stage carriage, under any permit issued therefor to such Undertaking under sub-section (1), any vehicle placed at the disposal and under the control of such Undertaking by the owner of such vehicle under any arrangement entered into between such owner and the Undertaking for the use of the said vehicle by the Undertaking”.
