

(b) To act as a Think Tank to suggest proactive policy changes that would enable the Union Territory to benefit from innovation and technology of the future.

- (c) To support the Union Territory to develop an Information Technology/Emerging Technologies Vision Plan/Road Map for long-term economic development of Puducherry.
- (d) To exchange ideas on some of the most pressing issues where Emerging Technologies may present sustainable solution for Puducherry across all types of economic activity in the Union Territory.

The Committee is envisioned as a Think Tank which would support Information Technology Department, Government of Puducherry in shaping a pathway for future development. The Committee shall provide advisory support through recommendation of initiatives beneficial for the State. The Advisory Committee will layout strategies for making Puducherry ready for wide-spread adoption of Emerging Technologies providing a head start in maximising the opportunities, it had to offer. The Committee will comprise of individuals who bring unique knowledge and skills by providing thought leadership and actionable insights.

4. Functions of the Advisory Committee

- (a) Provide feedback to the Information Technology Department from the Industry Associations,
- (b) Provide requisite technical expertise,
- (c) Provide an independent/unbiased sound board,
- (d) Enhance the Department's public standing and assist the Department in designing strategic initiatives.

Recommendations of the Committee shall be purely advisory in nature.

5. Appointment and Terms

- (a) The Committee shall comprise of 9 Members and Chairman with a term of 1 year and the composition could be amended by Principal Secretary, Information Technology, Government of Puducherry.
- (b) Any special invitees could be called to the meeting depending upon the agenda of that meeting, co-opt any experts/officials as necessitated.
- (c) The Committee shall meet at least once in quarter.
- (d) The list is non-exhaustive and will be updated based on the inputs of the Committee.
- (e) The Committee Members would be expected to comply with policies similar to those of a Governing Board of Directors (*e.g.*, meeting attendance, decision making, conflict of interest and ethics policies).

6. The Government also order that Members are liable to be changed or replaced time to time based on evolving needs of expertise and availability, and special invitees can be called as and when required by the Chairman and send its recommendations to Government for consideration.

3. The functions of the Committee are:

- (i) To issue suitable *addenda* in existing State RoW Policy for rolling out 5G infrastructure.
- (ii) Modalities for use of Government Infrastructure/ Street furniture for establishing telecom structures.
- (iii) Street furniture identification and data collection methodology. Uniform format to be adopted.
- (iv) Inventory must be uploaded in the RoW Portal by respective Departments.

- (v) To issue suitable guidelines to leverage street furniture and mechanism to accept bulk applications are to be considered for faster deployment of 5G rollout.
- (vi) The Committee should take monthly review on administrative issues.
- (vii) The Committee may explore finalising the common power consumption bill. Collective load of all 5G cells in one area as on connection and apply flat electricity charges on a monthly/ quarterly basis to be explored. Power reliability should be ensured for street furniture and poles for 5G rollout.
- (viii) Upgradation of electricity capacity to be expedited through dedicated teams assigned by Discoms in State. All pendencies to be tracked and worked on by Committee. Discoms to appraise the Committee on the foreseeable timelines on the closure of the upgrades.
- (ix) Security aspects need to be taken care off as theft of communication infrastructure.

4. The Chairman of the Committee is also authorised to co-opt any experts/officials as necessitated.
