The tenders in sealed cover should be addressed to the Block Development Officer, Villianur, Puducherry-605 110, duly superscribing on the envelope as "Tender for the purchase of e-waste items" and to reach the undersigned on or before 20-10-2022 by 4.00 p.m. The agents of the company shall produce authorisation letter of the company and Aadhaar Card of the agent. The received tenders will be opened on the same day at 4.30 p.m in the presence of the tenderers or their representatives who are present at that time. If, the opening day of the tenders happens to be a public holiday, the same will be opened on the next working day.

3. The intending tenderers (Registered e-waste recyclers) should deposit a sum of ₹ 2,000 (Rupees two thousand only) in cash as earnest money deposit at the time of submitting their tenders. The earnest money deposit of the unsuccessful tenderers will be refunded after finalization of the tender.

4. Tenders received after the due date and time will be rejected. The highest rate quoted in the tender will be minimum price and then the open auction will be conducted on the same day. In the open auction, the tenderers who have already submitted sealed tenders will only be allowed.
