NOTIFICATION

In exercise of the powers conferred by rule 10 of Renewable Energy Agency Puducherry (REAP) Rules and Regulations, the Governing Body hereby makes the following rules relating the method of recruitment to the Group 'A', Group 'B' and Group 'C' posts of the Renewable Energy Agency Puducherry.

- **1. Short title and commencement.—** (1) These rules may be called the Renewable Energy Agency Puducherry Group 'A', 'B' and 'C' posts Recruitment Rules, 2022.
 - (ii) They shall come into force on and from the date of their publication in the Official Gazette.
- 2. Number of post, their classification, Level in the Pay Matrix.— The number of the said post, their classification and the Level in the Pay Matrix attached thereto shall be as classified in columns (2) to (4) of the said Schedule.
- 3. Method of recruitment, age-limit and other qualifications.—The method of recruitment to the said post, age-limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (13) of the Schedule.
 - 4. Disqualifications.— No person,-
 - (a) Who has entered into or contracted a marriage with a person, having a spouse living; or
- (b) Who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Governing Body may, if satisfied that such marriage is permissible under the Personal Law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

- **5. Power to relax.** Where, the Governing Body is of the opinion that it is necessary or expedient so to do, he may, by order for reasons to be recorded in writing with the approval of Hon'ble Lieutenant-Governor, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Savings.— Nothing in these rules shall affect the reservations, relaxations in upper age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government of Puducherry from time to time in this regard.

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Notification No. F.5/4/65-GP, dated 11th January, 1965 of the Ministry of Home Affairs, Government of India, New Delhi and in supersession of the Notification issued *vide* G.O. Ms. No. 3, dated 20th September, 1995 and published in the Supplement to the Gazette No. 41, dated 10th October, 1995 of the General Administration (Information and Publicity) Department, Government of Puducherry, save as respects things done or omitted to be done before such supersession, the Lieutenant-Governor, Puducherry, hereby makes the following rules, regulating the method of recruitment to the post of Assistant Director in the Department of Information and Publicity, Government of Puducherry, namely:-

- 1. Short title and commencement.— (a) These rules may be called the Government of Puducherry, Department of Information and Publicity, (Assistant Director) Recruitment Rules, 2022.
 - (b) They shall come into force on and from the date of their publication in the Official Gazette.
- **2. Application.** These rules shall apply to the post specified in column-1 of the Schedule annexed to these rules.
- 3. Number of post, its classification and Level in the Pay Matrix.— The number of the said post, its classification and the Level in the Pay Matrix attached thereto, shall be as specified in columns (2) to (4) of the said Schedule annexed hereto.
- **4. Method of recruitment, age-limit and other qualifications.**—The method of recruitment to the said post, age-limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (13) of the said Schedule.
 - 5. Disqualifications.— No person,-
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Lieutenant-Governor may, if satisfied that such marriage is permissible under the Personal Law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

- **6. Power to relax.** Where, the Lieutenant-Governor is of the opinion that it is necessary or expedient so to do, he/she may, by order for reasons to be recorded in writing and in consultation with Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- 7. Savings.— Nothing in these rules shall affect the reservations, relaxations in upper age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, ex-servicemen and other special categories of persons in accordance with the orders issued by the Government of Puducherry from time to time in this regard.

Note 2: The eligibility service shall continue to be seven years for persons holding the feeder posts on regular basis on the date of Notification of these rules.

Note 3: For the existing incumbents holding the feeder posts on regular basis on the date of notification of these rules, the requirement of successful completion of training of 2-4 weeks in Public Relations and Sub-Editing for promotion shall be either before promotion or within a period of one year from the date or promotion.

Deputation (Including Short-Term Contract)

Officers of the Central Government/State Government/ Union Territory or Autonomous or Statutory Organization or Public Sector Undertaking or recognized University or research Institution:

- (a) (i) Holding analogous posts on regular basis in the parent cadre or Department: or
 - (ii) With 5 (five) years service rendered after appointment to the post on regular basis in Level-6 of the Pay Matrix or equivalent in the parent cadre or Department: and
- (b) Possessing the following educational qualification and experience.

Essential

- (i) A Bachelor Degree of a recognized University/Institution.
- (ii) 3 (three) years experience in the field of Protocol work/ Dissemination of Publicity Materials/Public Relations Work/Journalism/Organization of Exhibitions and Fairs/ Advertising in Central Government/State Government/ Union Territory or Statutory or Autonomous Organization or Public Sector Undertaking or recognized University or research Institution.

Desirable

- (i) Diploma in Mass Communication/Public Relations/ Advertising/Journalism from a recognized University or Institute.
- (ii) Should have studied Tamil or Malayalam or Telugu or French and English as a subject at Secondary level (10th class) or above.
- (iii) At least 6 (six) months Certificate or Diploma course in Computer Application from a recognized University or Institute.
- Note: (1) Where, Juniors who have completed their qualifying/eligibility service are being considered for promotion, their senior would also be considered provided they are not short of the requisite qualifying/eligibility service by more than half of such qualifying/eligibility service or 2 (two) years, whichever is less and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying/eligibility service.

Note: (2) The Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.

Note: (3) The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization/Department of the Central Government shall ordinarily not exceed three years. The maximum age-limit for appointment by deputation shall be not exceeding 56 years as on the last date of receipt of applications.
