THE PUDUCHERRY SETTLEMENT (AMENDMENT) ACT, 2022

(Act No. 5 of 2022)

An Act

further to amend the Puducherry Settlement Act, 1970.

BE it enacted by the Legislative Assembly of Puducherry in the Seventy-third Year of the Republic of India as follows :—

Short title, extent and commencement.

itle, 1. (1) This Act may be called as the Puducherry and Settlement (Amendment) Act, 2022.

(2) It extends to the whole of Union territory of Puducherry.

(3) It shall come into force with effect from the date of its publication in the Official Gazette.

Amendment of section 19.

2. (i) In the Puducherry Settlement Act, 1970 Act (hereinafter referred to as the Principal Act), in section 19, No.28 after sub-section (2), the following sub-section shall be of 1970.

(2A) Save as otherwise provided in this Act, upon receipt of a report under section 18, the officer specified by the Collector under sub-section (1) of section 17 shall automatically mutate the entries in the approved Register of Rights within a prescribed time-limit.

(ii) In sub-section (3) of the said section, after the words and figure "sub-section (2)", the word and figure "and (2A)" shall be inserted.

Amendment of section 21.

3. In clause (ii) of sub-section (1) of section 21 of the Principal Act, after the words and figure "sub-section(2)" the word and figures "and (2A)" shall be inserted.
