Kennedy Babu, Professor and Head, Department of Periodontics as Dean, Mahatma Gandhi Postgraduate Institute of Dental Sciences, Puducherry, on regular basis with retrospective effect from 04-09-2020.

2. He will continue to draw the same Pay in the Scale of Pay in Level 14 (7th CPC) and usual allowances as admissible under the Rules in force from time to time including Special Allowance of ₹ 3,000 per month.

3. He will continue to officiate in the same post of Dean, Mahatma Gandhi Postgraduate Institute of Dental Sciences, till he is attaining the age of superannuation of 65 years.
