- 2. The Counter Petitioner is Thiru Ganesh @ Kannukutti Ganesh @ Anandh (46), son of Gurusamy, a resident of No. 77, Bajanaimadam Street, Muthirayarpalayam, Puducherry.
- 3. The facts which led up to the petition are briefly as follows: The case is submitted by the Station House Officer, Mettupalayam Police Station, Puducherry, with the recommendation of the Superintendent of Police (North), Puducherry vide I.R.No. 01/2023 under section 144 of Cr.P.C., dated 04-01-2023. Therein, it has been stated that the Counter Petitioner have indulging in crimes such as murder, extortion, intimidation and disturbance to the public tranquility and order. It is also stated that the Counter Petitioner have created panic in the minds of local inhabitants and he is leading lavish life with the money earned through extortion. As a result the people of the locality being afraid of the Counter Petitioner do not come forward to lodge any complaint against him. It is also stated that even witnesses don't come forward voluntarily to give evidence against him in the cases where he is the accused. In this connection, the Petitioner had stated that the following criminal cases were registered against the Counter Petitioner.
  - Cr.No. 84/2017 under sections 147, 148, 342, 302, 307 IPC r/w 149 IPC and 3 and 4 of Explosives Substances Act, 1908 @ 148, 109, 120-B, 144, 114, 342, 302, 307, 326, 324 IPC r/w 149 IPC and, 3 and 4 of Explosives Substances Act 1908, dated 19-10-2017 of Mettupalayam Police Station, Puducherry.
  - 2. Cr.No. 96/2014 under sections 148, 302, 120(B), 109 IPC r/w 149 IPC, dated 13-08-2014 of Mettupalayam Police Station Pending Trial.
  - 3. Cr.No. 55/2014 under sections 324, 323, 506(ii)IPC r/w 34 IPC, dated 11-05-2014 of Mettupalayam Police Station, Puducherry Compounded.
  - 4. Cr.No. 27/2010 under section 25(1)(a) of Arms Act 1959, dated 18-02-2010 of Mettupalayam Police Station, Puducherry Acquitted.
  - 5. Cr.No. 95/2005 under sections 147, 148, 324, 302 r/w 149 IPC, dated 13-07-2005 of Mettupalayam Police Station, Puducherry Acquitted.

- 4. The Petitioner submitted that the Counter Petitioner is a notorious rowdy element and become a source of terror among the public. It is further stated that the Counter Petitioner also earned displeasure among a section of other rowdy group in the area on account of the grudge against him and hence, rival group is also waiting opportunity to take revenge upon him. It is also stated that he has involved in various offences by using arruval, knife to attack the victims and he violated the conditions imposed by the Criminal Courts and have scant respect to the judiciary and rule of law.
- 5. The Petitioner further submitted that if, the Counter Petitioner is allowed to reside in Puducherry North limits, it is apprehended that he would continue to indulge in serious offences like murder, extortion, assault, obstructions, annoyance, damages to public and private properties, *etc.*, and thereby emerged as a perennial source of threat to the community and disturb public peace and order. Hence, the Station House Officer, Mettupalayam Police Station, Puducherry, has prayed to invoke provisions under section 144 of Cr.P.C., against the Counter Petitioner to not to enter into the jurisdiction of this Court for a period of two months as to prevent danger to the human life and properties of citizens and uphold public peace and order.
- 6. The proceeding was started by affording an opportunity to the Counter Petitioner to show cause against the petition filed by the Petitioner. A notice was served to both the parties on 20-02-2023 to appear for the hearing on 23-02-2023 at 10.00 a.m. and subsequent hearings on 28-03-2023 and 13-04-2023 . It was instructed to serve the notice to the Counter Petitioner through the Station House Officer, Mettupalayam Police Station, Puducherry. The notice for the Counter Petitioner was received by his mother, Tmt. Lakshmi. The Service was held sufficient for the Counter Petitioner.
- 7. On 13.04.2023, the Petitioner Thiru G. Kalaiarasan, Sub-Inspector, Mettupalayam Police Station, Puducherry, was present. The Counter Petitioner has failed to appear before the Court on hearing date.
- 8. I have heard the Petitioner and carefully gone through all the available records in file placed by the Petitioner. In the Police Information Report/Petition, it is stated that the activities of Thiru Ganesh @ Kannukutti Ganesh @ Anandh, is in such a manner that he may cause breach of peace and create a problem of law and order and public tranquility. He has involved in crimes such as murder, assault, unlawful activities and disturbance to the public peace and order. There are 9 criminal cases were registered against him in Mettupalayam Police Station.
- 9. On perusal of the records submitted by the Petitioner and the recommendation of the Superintendent of Police (North), I am of the opinion that if, the Counter Petitioner is allowed to reside within the limits of my jurisdiction, the Counter Petitioner will continue to indulge in and also motivate serious offences like murder, assault, extortion, obstructions, annoyance, damages to public and private properties, *etc.*, and thereby emerged as a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C., is invoked to take action against the Counter Petitioner to prevent harm to life and properties of citizens and uphold public peace and order.

10. Hence, I, M. Kandasamy, do hereby, in the capacity of Subdivisional Magistrate (North), Puducherry, in exercise of powers conferred under section 144(1) of the Code of Criminal Procedure, pass this order and prohibit the Counter Petitioner Thiru Ganesh @ Kannukutti Ganesh @ Anandh (46), son of Gurusamy, a resident of No. 77, Bajanaimadam Street, Muthirayarpalayam, Puducherry, from entering into the region under the jurisdiction of the Subdivisional Magistrate Court (North), for a period of two months from the date of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry. However, the Counter Petitioner may represent against this order before the undersigned by post or by Counsel.

The notice for the Counter Petitioner was received by his sister, Ms. R. Deepika. The Service was held sufficient for the Counter Petitioner.
- 7. On 13-04-2023, the Petitioner Thiru G. Kalaiarasan, Sub-Inspector, Mettupalayam Police Station, Puducherry, was present. The Counter Petitioner has failed to appear before the Court on hearing date.
- 8. I have heard the Petitioner and carefully gone through all the available records placed before me. In the Police Information Report/Petition, it is stated that the activities of Thiru Nandhakumar @ Nandu, is in such a manner that he may cause breach of peace and create a problem of law and order and public tranquility. He has involved in crimes such as murder, assault, unlawful activities and disturbance to the public peace and order. There are 3 criminal cases were registered against him in Mettupalayam Police Station.
- 9. On perusal of the records submitted by the Petitioner and the recommendation of the Superintendent of Police (North), I am of the opinion that if the Counter Petitioner is allowed to reside within the limits of my jurisdiction, the Counter Petitioner will continue to indulge in and also motivate serious offences like murder, assault, extortion, obstructions, annoyance, damages to public and private properties, *etc.*, and thereby emerged as a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C., is invoked to take action against the Counter Petitioner to prevent harm to life and properties of citizens and uphold public peace and order.

10. Hence, I, M. Kandasamy, do hereby, in the capacity of Subdivisional Magistrate (North), Puducherry, in exercise of powers conferred under section 144(1) of the Code of Criminal Procedure, pass this order and prohibit the Counter Petitioner Thiru Nandhakumar @ Nandu (22), son of Rajinikanth, a resident of No. 02, 1st Cross, Manicka Chettiar Nagar, Shanmugapuram, Puducherry, from entering into the region under the jurisdiction of the Subdivisional Magistrate Court (North), for a period of two months from the date of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry. However, the Counter Petitioner may represent against this order before the undersigned by post or by Counsel.

This petition along with case sheet is filed by the Station House Officer, Mettupalayam Police Station, Puducherry praying to pass orders under section 144 of Cr.P.C., against Thiru Suriya @ Sankar Ganesh, to prevent imminent danger to human lives and properties and disturbance to the public tranquility and order, in the jurisdiction of this Court.

- 2. The Counter Petitioner is Thiru Suriya @ Sankar Ganesh (21), son of Ravi, a resident of No. 04, New Street, Sanarapet, Mettupalayam, Puducherry.
- 3. The facts which led up to the petition are briefly as follows: The case is submitted by the Station House Officer, Mettupalayam Police Station, Puducherry, with the recommendation of the Superintendent of Police (North), Puducherry *vide* I.R.No. 06/2023 under section 144 of Cr.P.C., dated 06-01-2023. Therein, it has been stated that the Counter Petitioner have indulging in crime such as murder, dacoity,

hurt, riot, intimidation and disturbance to the public tranquility and order. The Counter Petitioner has created panic in the minds of local inhabitants. It is also stated that he is leading lavish life with the money earned through extortion. As a result, the people of the locality being afraid of the Counter Petitioner do not come forward to lodge any complaint against him. It is also stated that even witnesses don't come forward voluntarily to give evidence against him in the cases where he is the accused. In this connection, the Petitioner had stated that the following criminal cases were registered against the Counter Petitioner.

- 3. Cr.No. 84/2017 under sections 147, 148, 342, 302, 307 IPC r/w 149 IPC and 3 and 4 of Explosives Substances Act 1908 @ 148, 109, 120-B, 144, 114, 342, 302, 307, 326, 324 IPC r/w 149 IPC and 3 and 4 of Explosives Substances Act 1908, dated 19-10-2017 of Mettupalayam Police Station, Puducherry.
- Cr.No. 77/2017 under sections 294(b), 324, 427, 506(ii) r/w 34 IPC @ 147, 148, 448, 294 (b), 324, 427, 506(ii) r/w 149 IPC, dated 29-03-2017 of D'Nagar Police Station, Puducherry.
- 4. The Petitioner further submitted that the Counter Petitioner is a notorious rowdy element and become a source of terror among the public. Hence, the Station House Officer, Mettupalayam Police Station, Puducherry, has prayed to invoke provisions under section 144 of Cr.P.C., against the Counter Petitioner to not to enter into the jurisdiction of this Court for a period of two months as to prevent danger to the human life and properties of citizens and uphold public peace and order.
- 6. The proceeding was started by affording an opportunity to the Counter Petitioner to show cause against the petition filed by the Petitioner. A notice was served to both the parties on 20-02-2023 to appear for the hearing on 23-02-2023 at 10.00 a.m. and subsequent hearings on 28-03-2023 and 13-04-2023. It was instructed to serve the notice to the Counter Petitioner through the Station House Officer, Mettupalayam Police Station, Puducherry.
