THE APPROPRIATION (NO. II) ACT, 2023  
(Act No. 3 of 2023)

(30-03-2023)

AN

ACT

**to authorise payment and appropriation of certain  
sums from and out of the Consolidated  
Fund of the Union territory of Puducherry  
for the services in respect of the Financial  
Year 2023-2024**

BE it enacted by the Legislative Assembly of  
Puducherry in the Seventy-fourth Year of the  
Republic of India as follows :—

Short title.

1. This Act may be called the Appropriation  
(No. II) Act, 2023.

Issue of  
₹ 11600,00,00,000  
from and out of  
the Consolidated  
Fund of the  
Union territory  
of Puducherry  
for the Financial  
Year 2023-2024.

2. From and out of the Consolidated Fund  
of the Union territory of Puducherry, there may  
be paid and applied sums not exceeding those  
specified in column (5) of the Schedule, amounting  
in the aggregate to the sum of Eleven thousand  
and six hundred crore rupees, towards defraying  
the several charges which will come in the course  
of payment during the Financial Year  
2023-2024 in respect of the services specified in  
column (2) of the Schedule.

Appropriation.

3. The sums authorised to be paid and applied  
from and out of the Consolidated Fund of the  
Union territory of Puducherry by this Act, shall be  
appropriated for the services and purposes expressed  
in the Schedule in relation to the said period.
