And whereas, I am convinced of your involvement in a criminal case as under—

1. Cr. No. 32/2022 under section 302 IPC r/w 34 IPC, dated 30-03-2022.

and your vengeful acts along with your accomplices against your opponents have created panic in the minds of the people.

And whereas, the Station House Officer, Kirumampakkam Police Station, Puducherry, has filed a case against you *vide* I.R.No. 05/2023 under section 144 of Cr.P.C., dated 07-03-2023. It is stated by the Station House Officer, Kirumampakkam Police Station, Puducherry, that you have formed a gang of rowdies and indulging in crime such as murder, hurt and disturbance to the public tranquility and order and you have created panic in the minds of local inhabitants. And whereas, the Station House Officer, Kirumampakkam Police Station, Puducherry, further submitted that if, you are allowed to reside in Subdivisional Magistrate (South) jurisdiction limits, it is apprehended that you would continue to indulge in serious offences like assault, rioting, criminal intimidation, obstructions, annoyance and disturbance to the public tranquility and order, *etc.*, and thereby emerged as a perennial source of threat to the community and disturb public peace and order;

And whereas, summons were served for your appearance on 27-04-2023, 25-05-2023, 02-06-2023, 08-06-2023 and 11-08-2023 to file your explanation/objection as to why the Subdivisional Magistrate (South), Villianur, Puducherry, should not order to prevent you from entering into the south region under section 144(3) of Cr.P.C. and you have put forth your side;
