The expenditure on the payment of Honorarium, sitting fees, other allowances and conveyance charges to the Chairperson shall be debitable to the Head of Account "2203 – Technical Education – 001 – Direction and Administration 001(02) – Directorate of Higher and Technical Education – 001(02) Puducherry region (28) Professional Services and (11) Domestic TE" in the budget.
