NOTIFICATION

Whereas, the proposal for revision of the minimum rates of wages payable to the employees under employment in Public Motor Transport in the Union territory of Puducherry, was published as required under clause (b) of sub-section (1) of section 5 of the Minimum Wages Act, 1948, (Central Act 11 of 1948) in Notification issued by the Labour Department *vide* G.O. Ms. No. 17/Lab./AIL/G/2022, dated 28-10-2022 and published in the Official Gazette of Puducherry No. 46, dated 15-11-2022, inviting objections or suggestions from all the persons likely to be affected thereby, within sixty days from the date of publication of the said notification in the Official Gazette;

And whereas, pursuant to the said notification, no objections or suggestions have been received within the above said stipulated time-limit;

And whereas, in pursuance of the proviso to sub-section (2) of section 5, the Minimum Wages Advisory Board, constituted under section 7 of the said Act, has also been consulted with regard of the aforesaid revision of minimum rates of wages;

Now, therefore, in exercise of the powers conferred under clause (b) of sub-section (1) of section 3, read with sub-section (2) of section 5 and sub-section (1) of section 13 of the Minimum Wages Act, 1948 (Central Act 11 of 1948) and in supersession of the notification issued under G.O. Ms. No. 06/AIL/Lab./G/2016, dated 10-08-2016 of the Labour Department, Puducherry, published in the Gazette of Puducherry No. 35, dated 30-8-2016, the Lieutenant-Governor, Puducherry, is pleased to revise the minimum rates of wages in respect of the employees employed in Public Motor Transport in the Union territory of Puducherry as specified in the Schedule hereunder:

(1) **Dearness Allowance.**— In addition to the above minimum wages, the employees shall be paid Dearness Allowance as follows:-

(i) The Dearness Allowance shall be linked to the Average Puducherry City Consumer Price Index points for the year 2021 *i.e.*, 366 points (with base year 2001=100) and for every raise of 1 point over and above 366 points, an increase of ₹ 34.75 per month shall be paid as Dearness Allowance.

(ii) The revision of Dearness Allowance shall be calculated from the 1st April of every year on the basis of the average of the indices of the preceding twelve months *i.e.*, from January to December.

(iii) The first calculation shall thus be effective from the date of publication of this Notification in the Official Gazette of Government of Puducherry, based on the average Puducherry City Consumer Price Index of the previous year.

2. Where, the nature of work is the same, no distinction in the payment of wages shall be made in the case of men and women workers.

3. To arrive at the daily wages, the monthly wages shall be divided by 26.

4. Wherever, the existing wages are higher than the minimum rates of wages fixed herein, the same higher rates of wages shall be continued to be paid.
