THE APPROPRIATION BILL, 2023

(Bill No. 1 of 2023)

A

BILL

to authorise payment and appropriation of certain further sums from and out of the Consolidated Fund of the Union territory of Puducherry for the services in respect of the period from 1-4-2022 to 31-3-2023.

BE it enacted by the Legislative Assembly of Puducherry in the Seventy-fourth Year of the Republic of India as follows :—

1. This Act may be called the Appropriation Act, 2023. Short title.
2. From and out of the Consolidated Fund of the Union territory of Puducherry, there may be paid and applied further sums not exceeding those specified in column (5) of the Schedule, amounting in the aggregate to the sum of Nine hundred eighty-nine crore, twenty-five lakh and eighty-nine thousand rupees, towards defraying the several charges which will come in the course of payment during the period from 1-4-2022 to 31-3-2023 in respect of the services specified in column (2) of the Schedule. Supplementary appropriation of ₹ 989,25,89,000 from and out of the Consolidated Fund of the Union territory of Puducherry for the period from 1-4-2022 to 31-3-2023.
3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the Union territory of Puducherry by this Act, shall be appropriated for the services and purposes expressed in the Schedule in relation to the said period. Appropriation.
