NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with Notification No. F5/4/65-GP, dated 11th January, 1965 of the Government of India, Ministry of Home Affairs, New Delhi and in supersession of the Finance Department's Notification-I issued in G.O. Ms. No. 69/99-F2, dated 7th December 1999 of the Finance Department, Government of Puducherry and published in Supplement to the Gazette No. 3, dated 18th January, 2000, save as respects things done or omitted to be done before such supersession, the Lieutenant-Governor, Puducherry, hereby makes the following rules regulating the method of recruitment to the Group 'A' post of Director of Accounts and Treasuries/Financial Controller in the Government of Puducherry, namely:-

1. *Short title and commencement.*— (1) These rules may be called the Government of Puducherry, Group 'A' post of Director of Accounts and Treasuries/Financial Controller Recruitment Rules, 2023.

(2) They shall come into force on and from the date of their publication in the Official Gazette.

2. *Number of post, its classification and Pay Band and Level in the Pay Matrix.*— The number of said post, its classification and Level in the Pay Matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed thereto.

3. *Method of recruitment, age-limit and other qualifications.*— The method of recruitment to the said post, age-limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedule.

4. *Disqualifications.*— No person, –

(a) who has entered into or contracted a marriage with a person, having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts:

Provided that the Lieutenant-Governor may, if satisfied that such marriage is permissible under the Personal Law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

5. *Power to relax.*— Where, the Lieutenant-Governor is of the opinion that it is necessary or expedient so to do, he/she may, by order and for reasons to be recorded in writing and in consultation with Union Public Service Commission, relax any of the provisions of these rules with the respect to any class or category of persons.

6. *Savings.*— Nothing in these rules shall affect the reservations, relaxations in upper age-limit and other concessions required to be provided for the Scheduled Castes and other special categories of persons in accordance with the orders issued by the Government from time to time in this regard.

Deputy Director of Accounts and Treasuries/Senior Accounts Officer in Level 8 in the Pay Matrix with 8 years of service in the grade rendered after appointment thereto on a regular basis and have successfully completed the short-term training in the Institute of Government Accounts Finance (INGAF), Department of Expenditure, Ministry of Finance or National Institute of Financial Management (NIFM) failing which Deputy Director of Accounts and Treasuries/Senior Accounts Officer with ten years of combined service in the grade of

Junior Accounts Officer (Level 7 of Pay Matrix) and Deputy Director of Accounts and Treasuries/Senior Accounts Officer (Level 8 of Pay Matrix) subject to a minimum of three years of regular service in the grade of Deputy Director of Accounts and Treasuries/Senior Accounts Officer.

Standard Note

Where, juniors who have completed their qualifying/eligibility service are being considered for promotion, their senior would also be considered provided they are not short of the requisite qualifying/eligibility service by more than half of such qualifying/eligibility service or two years, whichever is less and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying/eligibility service.
