ORDER

(UNDER SECTION 144 OF Cr. P.C.)

To

Thiru Saran @ Gundu Saran @ Saranraj (23), S/o. Anandh, No. 02, Mariamman Koil Street, Arasurpet, Puducherry.

Whereas, it has been made to appear before me that you have trivial and scant respect to the judiciary and rule of law and have involved in various offences against public tranquility, offences affecting property and human body and that you have become a perennial source of threat to the community, public peace and order;

And whereas, I am convinced of your involvement in various criminal cases as under-

and your vengeful acts along with your accomplices against your opponents has created panic in the minds of the people;

And whereas, the Station House Officer, Villianur Police Station, Puducherry, has filed a case against you *vide* IR.No. 25/2022 under section 144 of Cr.P.C., dated 15-06-2022. It is stated by the Station House Officer, Villianur Police Station, Puducherry that you are indulging in crime such as hurt, robbery offences under Arms Act, intimidation, rioting and disturbance to the public tranquility and order and you have created panic in the minds of local inhabitants. As a result, the people of the locality being afraid of you, do not come forward to lodge any complaint against you and it is also stated that even witnesses doesn't voluntarily come forward to give evidence against you in the cases where you are an accused;

And whereas, the Station House Officer, Villianur Police Station, further submitted that if, you are allowed to reside in Subdivisional Magistrate (South) jurisdiction limits, it is apprehended that you would continue to indulge in serious offences like murder, extortion, damages to public and private properties, assault, obstructions, annoyances and disturbance to the public tranquility and order, *etc.*, and thereby emerged as a perennial source of threat to the community and disturb public peace and order;

And whereas, summons were served for your appearance on 18-07-2022, 22-08-2022, 12-09-2022 and 26-12-2022 to file your explanation/objection as to why the Subdivisional Magistrate (South), Villianur should not order to prevent you from entering into the south region under section 144(3) of Cr. P.C. but, you have failed to appear before the Court and hence, the case is decided *ex parte* under section 144(2) of Cr. P.C. in the view of urgency of the matter;

And whereas, based on the report laid before me, I am of the opinion that if, you are allowed to reside within the limits of this jurisdiction, you will continue to indulge in and also motivate serious offences and thereby disturbing public tranquility and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C. is invoked against you to prevent harm to life and properties of citizens and uphold public peace and order. Therefore, an immediate action is required for curtaining your illegal activities in the locality;

Now, therefore, based on the reasons stated above, I, K. Muralidharan, Subdivisional Magistrate (South), Puducherry, in exercise of powers conferred under Code of Criminal Procedure, do hereby prohibit you under section 144 of Cr. P.C. from entering into the Subdivisional Magistrate (South) jurisdiction for two months from the date of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry. However, you may appear either in person or by Pleader before the undersigned to represent against the order.
