NOTIFICATION

Approval of the Hon'ble Lieutenant-Governor, Puducherry, is hereby accorded to compound fines and penalties by the Department of Food Safety, Puducherry, as per section 69 of Food Safety and Standards Act, 2006 to compound the offence committed by the Food Business Operators classified in Reg. 1.2.1 (4), in the Union territory of Puducherry, before imposing compound fines and penalties on Food Business Operators who fail to comply with any Regulations of the Food Safety and Standards Act, 2006, an Improvement Notice shall be issued in the first instance.

The compound fines and penalties as detailed below:

- 2. The Penalty should be paid by the Food Business Operators at Treasury in the Head of Account namely, "0210-Medical and Public Health 04 Public Health 104 Fees and Fines *etc.* 02 Food Safety", by the e-challan. No penalty has to be collected in cash.
