Murugan, Sub-Inspector, Reddiyarpalayam Police Station, Puducherry, praying to pass orders under section 144 of Cr.P.C., against Thiru Manikandan @ Bomb Mani (34), to prevent imminent danger to human lives and properties and disturbance to the public tranquility and order, in the jurisdiction of this Court.

- 2. The Counter Petitioner is Thiru Manikandan @ Bomb Mani (34), son of Velu, a resident of No. 26, 5th Cross Street, JJ Nagar, Moolakulam, Puducherry.
- 3. The facts which led up to the petition are briefly as follows: The case submitted by the Station House Officer, Reddiyarpalayam Police Station, Puducherry, with the recommendation of the Superintendent of Police (North), Puducherry vide I.R.No. 01/2023 under section 144 of Cr.P.C., dated 28-03-2023. Therein it has been stated that the Counter Petitioner has formed a gang of rowdies and bent upon indulging in crime such as attempt to murder, extortion, hurt, intimidation, riot, dacoity, affray and disturbance to the public tranquillity and order. The Counter Petitioner has created panic in the minds of local inhabitants and the business community in the city limit. It is also stated that he is leading lavish life with the money earned through extortion. As a result, the people of the locality being afraid of the Counter Petitioner do not come forward to lodge any complaint against him. It is also stated that even witnesses don't come forward voluntarily to give evidence against him in the cases where he is the accused. In this connection, the Petitioner had stated that the following criminal cases were registered against the Counter Petitioner.

It is also stated in the I.R that the Station House Officer has received reliable information that the Counter Petitioner are hatching plans to threaten the business people in the Puducherry urban area and extort money from them by threatening and he is desperate and is in dire need of money to maintain his group of rowdy elements and to meet expenses in connection with the trial in the pending criminal cases against him. The Petitioner also stated that the Counter Petitioner earned displeasure among a section of other rowdy group in the area on account of the grudge against him and hence, rival group is also waiting opportunity to take revenge upon him.
- 6. The Petitioner further, submitted that if, the Counter Petitioner is allowed to reside in Puducherry limits, it is apprehended that he would continue to indulge in serious offences like murder, attempt to murder, extortion, kidnapping, damages to public and private properties, assault, obstructions, annoyance, *etc.*, and thereby emerged as a perennial source of threat to the community and disturb public peace and order. Hence, the Station House Officer, Reddiyarpalayam Police Station, Puducherry, has prayed to invoke provisions under section 144 of Cr.P.C., against the Counter Petitioner to not to enter into the jurisdiction of this Court for a period of two months as to prevent danger to the human life and properties and disturbance to the public tranquility and order.
- 7. The proceeding was started by affording an opportunity to the Counter Petitioner to show cause against the petition filed by the Petitioner. A notice was served to both the parties on 28-04-2023 to appear for the hearing on 16-05-2023 at 10.00 a.m. It was instructed to serve the notice to the Counter Petitioner through the Station House Officer, Reddiyarpalayam Police Station, Puducherry. The notice was received by the Counter Petitioner.
- 8. On 16-05-2023, the Petitioner Thiru D. Murugan, Sub-Inspector, Reddiyarpalayam Police Station, Puducherry was present. The Counter Petitioner has failed to appear before the Court on hearing date.
- 9. I have heard the Petitioner and carefully gone through all the available records placed before me. In the Police Information Report/Petition, it is stated that the activities of Thiru Manikandan @ Bomb Mani (34), is in such a manner that he may cause breach of peace and create a problem of law and order and public tranquility. He has involved in crimes such as murder, unlawful activities and disturbance to the public peace and order. There are 12 criminal cases were registered against him in various Police Stations.
- 10. On perusal of the records submitted by the Petitioner and the recommendation of the Superintendent of Police (North), I am of the opinion that if, the Counter Petitioner is allowed to reside within the limits of my jurisdiction, the Counter Petitioner will continue to indulge in and also motivate serious offences

like murder, extortion, assault, damages to public and private properties, obstructions, annoyance, *etc.*, and thereby become a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C., is invoked to take action against the Counter Petitioner to prevent harm to life and properties of citizens and uphold public peace and order.

11. Hence, I, M. Kandasamy, do hereby in the capacity of Subdivisional Magistrate (North), Puducherry, in exercise of powers conferred under section 144(1) of the Code of Criminal Procedure, pass this order and prohibit the Counter Petitioner Thiru Manikandan @ Bomb Mani (34), son of Velu, a resident of No. 26, 5th Cross Street, JJ Nagar, Moolakulam, Puducherry, from entering into the region under the jurisdiction of the Subdivisional Magistrate Court (North), for a period of two months from the date of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry. However, the Counter Petitioner may represent against this order before the undersigned by post or by Counsel.

The Petitioner further, submitted that if, the Counter Petitioner is allowed to reside in Puducherry limits, it is apprehended that he would continue to indulge in serious offences like murder, attempt to murder, assault, obstructions, annoyance *etc.*, and thereby emerged as a perennial source of threat to the community and disturb public peace and order. Hence, the Station House Officer, Reddiyarpalayam Police Station, Puducherry, has prayed to invoke provisions under section 144 of Cr.P.C., against the Counter Petitioner to not to enter into the jurisdiction of this Court for a period of two months as to prevent danger to the human life and properties and disturbance to the public tranquility and order.

Kandasamy, do hereby in the capacity of Subdivisional Magistrate (North), Puducherry, in exercise of powers conferred under section 144(1) of the Code of Criminal Procedure, pass this order and prohibit the Counter Petitioner Thiru Prakash @ Gundu Prakash (25), son of Palanivel, a resident of 10th Cross, JJ Nagar, Moolakulam, Puducherry, from entering into the region under the jurisdiction of the Subdivisional Magistrate Court (North), for a period of two months from the date of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry. However, the Counter Petitioner may represent against this order before the undersigned by post or by Counsel.

#### ORDER

(UNDER SECTION 144 OF Cr.P.C.)

Counter Petitioner

This petition along with case sheet is filed by Station House Officer, Thiru D. Murugan, Sub-Inspector of Police, Reddiyarpalayam Police Station, Puducherry, praying to pass orders under section 144 of Cr.P.C., against Thiru Sathishkumar @ Sathish @ Ice, to prevent imminent danger to human lives and properties and disturbance to the public tranquility and order, in the jurisdiction of this Court.

- 2. The Counter Petitioner is Thiru Sathishkumar @ Sathish @ Ice (24), son of Siva @ Shanmugam, a resident of No. A-14, Mariamman Koil Street, Pavanar Nagar, Boomiyanpet, Puducherry.
- 3. The facts which led up to the petition are briefly as follows: The case submitted by the Station House Officer, Reddiyarpalayam Police Station with the recommendation of the Superintendent of Police (North), Puducherry vide

I.R.No. 08/2023, under section 144 of Cr.P.C., dated 04-04-2023. Therein it has been stated that the Counter Petitioner has formed a gang of rowdies and bent upon indulging in crime such as murder, attempt to murder, extortion, hurt, intimidation and disturbance to the public tranquility and order. The Counter Petitioner has created panic in the minds of local inhabitants and the business community in the city limit. It is also stated that he is leading lavish life with the money earned through extortion. As a result, the people of the locality being afraid of the Counter Petitioner do not come forward to lodge any complaint against him. It is also stated that even witnesses don't come forward voluntarily to give evidence against him in the cases where he is the accused. In this connection, the Petitioner had stated that the following criminal cases were registered against the Counter Petitioner.

- 1. Cr. No. 71/2018 under sections 294(b), 324, 323, 506(ii) r/w 34 IPC, dated 30-05-2018 of Reddiyarpalayam Police Station, Puducherry.
- 2. Cr.No. 120/2018 under sections 341, 302 r/w 34 IPC @ 148, 341, 302, 120(B) IPC r/w 149 IPC, dated 30-09-2018 of Reddiyarpalayam Police Station, Puducherry.
- 3. Cr.No. 99/2022 under sections 147, 307, 324 IPC r/w 149 IPC, dated 04-08-2022 of Reddiyarpalayam Police Station, Puducherry.
- 4. The Petitioner further, stated that the Counter Petitioner is a rowdy element and become a source of terror among the public and he has involved in various offences by using arruval, knife and other dangerous weapons to attack the victims.
- 5. It is also stated in the I.R that the Station House Officer have received reliable information that the Counter Petitioner are hatching plans to threaten the business people in the Puducherry urban area and extort money from them by threatening and he is desperate and is in dire need of money to maintain his group of rowdy elements and to meet expenses in connection with the trial in the pending criminal cases against him. The Petitioner also stated that the Counter Petitioner earned displeasure among a section of other rowdy group in the area on account of the grudge against him and hence, rival group is also waiting opportunity to take revenge upon him.
- 6. The Petitioner further, submitted that if the Counter Petitioner is allowed to reside in Puducherry limits, it is apprehended that he would continue to indulge in serious offences like murder, attempt to murder, extortion, kidnapping, damages to public and private properties, assault, obstructions, annoyance, *etc.*, and thereby emerged as a perennial source of threat to the community and disturb public peace and order. Hence, the Station House Officer, Reddiyarpalayam Police Station, Puducherry, has prayed to invoke provisions unde section 144 of Cr.P.C. against the Counter Petitioner to not to enter into the jurisdiction of this Court for a period of two months as to prevent danger to the human life and properties and disturbance to the public tranquility and order.
- 7. The proceeding was started by affording an opportunity to the Counter Petitioner to show cause against the petition filed by the Petitioner. A notice was served to both the parties on 28-04-2023 to appear for the hearing on 16-05-2023 at 10.00 a.m. It was instructed to serve the notice to the Counter Petitioner through the Station House Officer, Reddiyarpalayam Police Station, Puducherry. The notice was received by the Counter Petitioner.

- 8. On 16-05-2023, the Petitioner Thiru D. Murugan, Sub-Inspector of Police, Reddiyarpalayam Police Station, Puducherry was present. The Counter Petitioner has failed to appear before the Court on hearing date.
- 9. I have heard the Petitioner and carefully gone through all the available records placed before me. In the Police Information Report/Petition, it is stated that the activities of Thiru Sathishkumar @ Sathish @ Ice, is in such a manner that he may cause breach of peace and create a problem of law and order and public tranquility. He has involved in crimes such as murder, assault, unlawful activities and disturbance to the public peace and order. There are 3 criminal cases were registered against him in Reddiyarpalayam Police Station, Puducherry.
- 10. On perusal of the records submitted by the Petitioner and the recommendation of the Superintendent of Police (North), I am of the opinion that if the Counter Petitioner is allowed to reside within the limits of my jurisdiction, the Counter Petitioner will continue to indulge in and also motivate serious offences like murder, extortion, assault, damages to public and private properties, obstructions, annoyance, etc., and thereby become a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C., is invoked to take action against the Counter Petitioner to prevent harm to life and properties of citizens and uphold public peace and order.
- 11. Hence, I, M. Kandasamy, do hereby, in the capacity of Subdivisional Magistrate (North), Puducherry, in exercise of powers conferred under the section 144(1) of the Code of Criminal Procedure, pass this order and prohibit the Counter Petitioner Thiru Sathishkumar @ Sathish @ Ice (24), son of Siva @ Shanmugam, a resident of No. A-14, Mariamman Koil Street, Pavanar Nagar, Boomiyanpet, Puducherry, from entering into the region under the jurisdiction of the Subdivisional Magistrate Court (North), for a period of two months from the date of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry. However, the Counter Petitioner may represent against this order before the undersigned by post or by Counsel.
