GOVERNMENT OF PUDUCHERRY LAW DEPARTMENT

(G.O. Ms. No. 25/2023-LD., Puducherry, dated 22nd June 2023)

ORDER

Whereas, the proposal for creation of two posts of whole-time Secretaries for the District Legal Services Authority, one for the Puducherry District and the other for the Karaikal District, alongwith the supporting ministerial/clerical staff in the Union territory of Puducherry, has been initiated in compliance with the resolutions and directions of the National Legal Services Authority, New Delhi, at in the 13th All India Meet of State Legal Services Authorities held at Ranchi on 21-03-2015 and 22-03-2015.

2. And whereas, in accordance with section 9(3) of the Legal Services Authority Act, 1987 and consequent upon the decisions taken at the National level and on the instructions of the Hon'ble Executive Chairman, National Legal Services Authority, the Member-Secretary, Union territory of Puducherry Legal Services Authority, Puducherry, has requested that a decision should be taken to create the post of whole-time Secretary with a designation of Secretary, District Legal Services Authority *vide* Lr.No. 400/UTPLSA-2017, dated 18-04-2017 of the Union territory of Puducherry Legal Services Authority, Puducherry.

- 3. And whereas, the Registrar (Recruitment), Hon'ble High Court of Madras, has communicated the Minutes of the Monitoring Committee Meeting held on 31-01-2019 *vide* D.O. Letter No. 1/2019/CJCS, dated 15-03-2019 of the Registrar (Recruitment) and (Special Cell) (FAC), High Court, Madras. Therein, it was resolved to create the two posts of whole-time Secretaries, District Legal Services Authority (DLSA) for Puducherry District and Karaikal District.
 - 4. And whereas, the details of posts proposed for creation of the
 - (i) District Legal Services Authority, Puducherry;
 - (ii) District Legal Services Authority, Karaikal, are as follows:

- 5. And whereas, the Department of Expenditure, Ministry of Finance, Government of India *vide* Office Memorandum No. 7(2)/E.Coord/2013, dated 18th September, 2013 has imposed a total ban on the creation of Plan and Non-Plan posts. In view of the ban imposed by the Government of India, the proposals relating to the creation of two posts of whole-time Secretaries, District Legal Services Authority, one in Puducherry District and another in Karaikal District alongwith supporting ministerial/clerical staff in the Union territory of Puducherry, requires sanction of the Ministry of Home Affairs, Government of India.
- 6. And whereas, the Finance Department, Puducherry, has approved the abovesaid proposal for taking up with the Department of Justice, Ministry of Law and Justice, Government of India through Ministry of Home Affairs, New Delhi. The approval of the Hon'ble Chief Minister and the Hon'ble Lieutenant-Governor, Government of Puducherry, have also been obtained in the abovesaid proposal before referring the same to the Government of India.
- 7. And whereas, the proposal was taken up with the Government of India *vide* Letter No. 1019/2020-LD., dated 14-01-2020 of the Law Department, Puducherry.
- 8. And whereas, *vide* Lr.No. A-60011/45/2016-LAP(JUS)(1940), dated 03-10-2022 of the Department of Justice, Ministry of Law and Justice, Government of India, New Delhi, the Department of Justice, Ministry of Law and Justice, has informed that the post Secretary in DLSA is a Statutory post and do not require their approval for creation, which was communicated to NALSA *vide* Letter, dated 21-06-2022.
- 9. And whereas, *vide* Lr. No. 13034/25/2020-CPD(Pudu), dated 13-10-2022 of the Ministry of Home Affairs, Government of India, New Delhi, the Ministry of Home Affairs, Government of India, has instructed to take up the matter with the National Legal Services Authority (NALSA).

- 10. And whereas, *vide* Lr.No. 1175/UTPLSA/2022, dated 10-11-2022 of the Union territory of Puducherry Legal Services Authority, Puducherry, the Member-Secretary, Union territory of Puducherry Legal Services Authority, Puducherry, has communicated the Letter No. A/07/2020-NALSA/3520, dated 11-10-2022 received from the National Legal Services Authority (NALSA), New Delhi.
- 11. And whereas, *vide* Lr. No. A/07/2020-NALSA/3520, dated 11-10-2022 of the National Legal Services Authority (NALSA), New Delhi, the NALSA has instructed to take necessary steps for appointing Secretary for DLSA(s) in the Union territory of Puducherry, with supporting staff strictly in accordance with section 9(3) and section 9(5) of the Legal Service Authority Act, 1987 as advised by the Department of Justice, Ministry of Law and Justice, Government of India.
- 12. Now, therefore, the Lieutenant-Governor, Puducherry, is pleased to sanction creation of two posts of whole-time Secretaries, District Legal Services Authority, one for the Puducherry District and other for the Karaikal District.
- 13. The expenditure is debitable from the Head of Account of the Union Territory of Puducherry Legal Services Authority (UTPLSA), Puducherry (State Authority) in the Budget.
- 14. This issues with concurrence of the Finance Department *vide* their l.D. No. 001/FD/F3/FC/2023-24, dated 05-04-2023.
