NOTIFICATION

The Lieutenant-Governor, Puducherry, is hereby pleased to make the following rules further to amend the "Rules for the Grant of Various subsidy Components and for Reimbursement/Spot Exemption of Sales tax on High Speed Diesel Oil to Marine Fishermen Rules - 2008" previously notified *vide* G.O. Ms. No. 10/Fy., dated 26-05-2009 of the Department of Rural Development, Chief Secretariat (Fisheries), Puducherry, and published *vide* Extraordinary Gazette Part- II, No. 15, dated 01-06-2009 of the Government of Puducherry (hereinafter referred to as the said rules)

and further amended *vide* G.O. Ms. No. 20/Fy., dated 15-11-2010 of the Deputy Secretary to Government, Chief Secretariat (Fisheries), Puducherry, and G.O. Ms. No. 13/Fy., dated 31-03-2023 of the Under Secretary to Government, Chief Secretariat (Fisheries), Puducherry, namely:-

#### AMENDMENT

**1. Short title and commencement.**— (i) These rules may be called the “Rules for Grant of various subsidy components and for Reimbursement/Spot Exemption of Sales tax on High Speed Diesel Oil to Marine Fishermen under Marine Sector Schemes “Development of Marine Fisheries through Mechanization and Reimbursement of Sales tax on High Speed Diesel Oil and Assistance to Small Scale Fishermen (Amendment) -2023”.

(ii) It shall extend to the whole of the Union territory of Puducherry.

(iii) They shall come into force with effect from the date of publication in the Official Gazette.

**2. Amendment of Rule 4.**— In the said rules, in rule 4.—

(i) after sub-clause (i) of clause (d), the following sub-clause shall be inserted, namely:-

(ia) The registered mechanized boat should be insured comply with colour coding as per the Government notification.

(ii) after sub-clause (i) of clause (e), the following sub-clause shall be inserted, namely:-

(ia) The registered mechanized boat should be insured against marine risks on annual basis with authorized Insurance company and comply to colour coding.

**3. Amendment of Rule 5.**— In the said rules, in rule 5.—

(i) for sub-clause (i) of clause (d), the following shall be substituted namely:-

“90% subsidy on the actual annual boat insurance premium paid by the owners without maximum ceiling”.

(ii) for sub-clause (i) of clause (e), the following shall be substituted, namely:-

“Financial grant for reactivation of a registered wooden/ steel and FRP mechanized boat will be extended @ ₹ 30,000 per boat/per annum and ₹ 20,000 per boat/per annum for a registered FRP mechanized inboard engine (Gill netters boat)”.

4. After existing rule 6 of the said rules, the following rules shall be inserted, namely:-

7. *Grant of subsidy*:- The quantum of subsidy shall be fixed by the Government from time to time for all the category under the Scheme.

8. *Interpretation and clarification*:- In the implementation of the subsidy Scheme, if, any doubt arises in regard to the interpretation of any of the provisions of the Scheme or if, any point required clarification, the matter shall be referred to the Secretary to Government (Fisheries) whose decision shall be the final.

5. This issues with the concurrence of the Finance Department, Puducherry *vide* their I.D. Note No. 165/FC/FD/F3/A4/2023-24, dated 26-05-2023.
