ORDER

The Ministry of Power, Government of India has notified a new Scheme "Revamped Reforms Based Results-Linked Power Distribution Scheme" with the objective of improving the quality and reliability of power supply to the consumers through a financially sustainable and operationally efficient distribution sector *vide* Office Memorandum No. 20/9/2019-IPDS, dated 20-07-2021 of Ministry of Power, Government of India, New Delhi. As per the directives of Ministry of Power, Government of India, a Distribution Reforms Committee (DRC) has been constituted by the Government *vide* G.O Ms. No. 30, dated 26-10-2021 of Industrial Development (Power) Department, Puducherry, to review the progress of the Scheme in the State Level.

2. Subsequently, the Ministry of Power, Government of India *vide* Letter No. F.No. 14/01/2021-UR & SI-II-(E-257559), dated 02-02-2023 of Ministry of Power, Government of India, New Delhi, has directed to include the Secretary in-charge from State Government for Panchayat Raj, Urban Development, Housing and Water Supply and Sanitation as Members of the DRC additionally and CMDs/MDs of DISCOMs in the State as permanent invitee in DRC meetings.

3. Accordingly, approval is hereby conveyed for reconstituting the Distribution Reforms Committee (DRC) for Union territory of Puducherry, under the Chairmanship of Chief Secretary to Government with the following composition:

4. The Distribution Reforms Committee (DRC) shall review the progress of the Scheme at the State Level. Without prejudice to the generality of the above, it shall:

- (i) Recommend the Action Plan for approval of State Cabinet.
- (ii) Recommend the DPRs for approval of Monitoring Committee.
- (iii) Approve change in the mode of execution with the consent of the Nodal Agency.
- (iv) Monitor the implementation of the Action Plan.
- (v) Monitor physical and financial progress including the quality of the projects.
- (vi) To review progress on implementation atleast once in a quarter (3 months) and share details of proceedings to Nodal Agency.
- (vii) Review of compliance with respect to Pre-Qualifying (PQ) criteria and progress on all parameters of the approved Result Evaluation Matrix.
- (viii) To pay special attention towards Consumer engagement while reviewing progress of Smart Metering works.

5. The DISCOM/Electricity Department, Puducherry, shall be responsible for implementing the Scheme as per guidelines, under the overall guidance of the DRC, Nodal Agencies and the Monitoring Committee, and shall have the following functions:

- (i) Preparation of Action Plans and DPRs and online submission of the same to the Nodal Agency.
- (ii) Implementation of the Scheme within the scheduled completion period as per guidelines.
- (iii) Appointment of Project Management Agency (PMA).
- (iv) Establishment of a dedicated Project Implementation Cell at District Level and a Centralized Cell at Head Office Level.
- (v) Submission of updated monthly physical and financial progress of the project to the Nodal Agency including its update on the web portal.
- (vi) Ensuring that there is no duplication/overlapping of works with any other Government of India and State Scheme.
- (vii) Providing information to the Nodal Agency as and when required.

In compliance with the directives issued by the Hon'ble Supreme Court of India, under Article 142 of the Constitution of India, in Writ Petition (Civil) No. 350 of 1993 in the matter of Islamic Academy of Education and Another Vs. State of Karnataka and Others, dated 14-08-2003, "Fee Committee" to determine the fee structure in the Unaided Private Professional Educational Institutions functioning in the Union territory of Puducherry was constituted *vide* G.O. Ms. No. 13, dated 07-06-2021 of the Chief Secretariat (Higher and Technical Education), Puducherry.

2. In partial modification of the G.O. Ms. No. 13, dated 07-06-2021 of the Chief Secretariat (Higher and Technical Education), Puducherry and on the recommendation of the Acting Chief Justice of the High Court, Madras, the Lieutenant-Governor, Puducherry, is pleased to appoint Hon'ble Thiru Justice B. Rajendran, Judge (Retd.), High Court, Madras, as Chairman of the "Fee Committee" for a period of three years from the date of assumption of charges.

3. The terms and conditions of appointment of the Chairman, Fee Committee, are as specified below:

(a)	Term	Three years from the date of assumption of the charges or till the necessity thereof ceases, whichever is earlier.	
(b)	Particulars of sittings	<i>Honorarium</i>	<i>Sitting fees</i>
	8 sittings and above	₹ 40,000 per month.	₹ 3,500 per sitting.
	7 sittings and below	₹ 20,000 per month.	₹ 3,500 per sitting.
(c)	Accommodation	Free facility of temporary Government accommodation in guest house, during sittings.	
(d)	Travelling Allowance	Travelling Allowance or A/C Car will be provided during the sittings and for <i>to and fro</i> journeys between the place of residence and Puducherry. If, own car is utilised for the above purpose, they are entitled to claim the admissible mileage allowance for the road journey as per rules in force. The above claim shall be as applicable to the judges of the High Court, Madras.	
(e)	Pension or Gratuity	The Chairman, Fee Committee, shall not be entitled for pension or gratuity for his tenure in the Fee Committee.	
(f)	Daily Allowance	The Chairman of Fee Committee is eligible for DA on par with Hon'ble Judges of the High Court, Madras for sittings each day.	

4. The Director of Higher and Technical Education, Puducherry, is declared as the Drawing and Disbursing Officer for the purpose of drawing the pay and to meet out other expenses relating to the above-mentioned Fee Committee during its tenure.

5. The expenditure on the payment of honorarium, sitting fees, other allowances and conveyance charges to the Chairman shall be debitable to the Head of Account "2203 – Technical Education – 001 – Direction and Administration 001(02) – Directorate of Higher and Technical Education – 001(02) Puducherry region (28) Professional Services and (11) Domestic TE" in the budget.
