NOTIFICATION

The Lieutenant-Governor, Puducherry, hereby makes the following Bye-laws further to amend the rules relating to composition of the Management Committee for the Armed Forces Flag Day Funds and the enhancement of financial assistance to Ex-servicemen and their families registered in the Department of Sainik Welfare, Government of Puducherry, issued *vide* Notification in G.O. Ms. No. 49, dated 28th September, 2012 of Home Department, Government of Puducherry and published in Part II, No. 37, dated 3rd October, 2012 of the Extraordinary Gazette of Puducherry, namely:-

1. Short title and commencement.— (i) These Bye-laws shall be called "The Management Committee for Armed Forces Flag Day Funds (Amendment) Bye-laws, 2023".

(ii) They shall come into force with immediate effect.

2. Amendment of clause 3.— (i) In the Management Committee for Armed Forces Flag Day Funds Bye-laws (hereinafter referred to as the said Bye-laws), for the existing clause 3, the following shall be substituted, namely:-

"3(1) The Management Committee of Armed Forces Flag Day Funds is a wing of the Sainik Welfare Department which is responsible for the judicious use of the Armed Forces Flag Day Funds by giving Financial Assistance, Grants and other welfare measures to the Ex-servicemen from the Armed Forces Flag Day Funds. The Management Committee shall have the following composition, namely:-

(ii) The existing clause (3)(1) shall be renumbered as clause 3(2).

(iii) The existing clause (3)(2) shall be renumbered as clause 3(3)."

3. Amendment of clause 4.— (i) In the said Bye-laws, for the existing clause 4(1), the following shall be substituted, namely:-

"4(1). 'Committee' means, the Managing Committee which consists of the Chairperson, Vice-Chairperson, Official Members, Non-Official Members and Co-opted Members and the Member-Secretary of the Sainik Welfare Department."

(ii) For the existing clause 4(3), the following shall be substituted, namely:-

"4(3). 'Fund' means, the Armed Forces Flag Day Fund which is utilized for the welfare and rehabilitation of Ex-Servicemen/ Widows and their dependants of the Union territory of Puducherry.

4. Amendment of clause 5.— In the said Bye-Laws, for the existing clause 5, the following shall be substituted, namely:-

"5. Composition of Executive Sub-Committee.— The Management Committee may appoint an executive Sub-Committee formed from amongst its Official Members as detailed below to which it may delegate such powers as it may deem fit. It may also be empowered to approve/reject the proposals submitted by the Member-Secretary of the Committee (Director, Sainik Welfare) for Grant/Assistance from the Armed Forces Flag Day Fund, which will be ratified by the Chairperson on the recommendation of Vice-Chairperson.

5. Amendment of clause 7.— In the said Bye-laws, for the existing clause 7, the following shall be substituted, namely:-

"7. Objects of the fund.— The objects of the fund are to award Financial Assistance/Cash Incentives under various Schemes and other privileges to Ex-Servicemen/Widows of Ex-Servicemen for their welfare and rehabilitation and the schemes introduced by the Government of Puducherry from time to time. These Awards/Incentives may be withdrawn by the Managing Committee, as and when necessary. The day-to-day requirements of Jawan Bhawan and its staffing shall be met from this fund as the Jawan Bhawan itself is a welfare measure to the Ex-Servicemen/Widows of Ex-Servicemen."

6. Amendment of clause 13.— In the said Bye-laws, for the existing clause 13, the following shall be substituted, namely:-

"13. Deposit and investment of money.— The Managing Committee shall invest a portion of the money of the fund in Nationalised/Scheduled Banks. It may keep the balance of the money in one or more accounts in any of the Nationalised/Scheduled Bank in Puducherry."

7. Amendment of clause 25.— In the said Bye-laws, for the existing clause 25, the following shall be substituted, namely:-

"25. Marriage Grant.— As decided by the Managing Committee, Marriage Grant shall be granted to Ex-Servicemen/Widows of Ex-Servicemen for the marriage of his/her daughter. Any further increase in the Marriage Grant will be fixed as prescribed by the Management Committee from time to time. Marriage Grant will be admissible for only two daughters. Application for this Grant should be submitted to the Department of Sainik Welfare along with marriage Registration Certificate of his/her daughter and original bill for purchase of utensil/cloth/jewels, *etc.*, within three months from the date of marriage. Marriage grants will be admissible to those who have not availed the same from the Kendriya Sainik Board, New Delhi."

8. Amendment of Annexure A.— In the said Bye-laws, for the existing Annexure-A, the following shall be substituted, namely:-
