NOTIFICATION

Whereas, the implementation of various Schemes by District Industries Centre, Puducherry, included in the XI Five Year Plan have been approved by the Government of Puducherry vide G.O. Ms. No. 21/2007-Ind.C., dated 24-3-2008 of the Department of Industrial Development (Industries and Commerce), Puducherry and published in the Extraordinary Gazette of Puducherry, No. 11, dated 28-03-2008 and vide G.O. Ms. No. 1/2009-Ind.C., dated 15-04-2009 of the Department of Industrial Development (Industries and Commerce), Puducherry and published in Extraordinary Gazette of Puducherry, No. 13, dated 16-04-2009;

2. And whereas, certain modification to these Schemes were found necessary;

3. And whereas, the General Manager, District Industries Centre, Puducherry, has sent a Proposal *vide* ID. Note No. J11011/01/2023-24/DIC/EI/Stipend, dated 06-06-2023 of the General Manager, District Industries Centre, Puducherry, containing certain amendments to these Schemes and the same have been examined and considered by Government;

4. Now, therefore, the Lieutenant-Governor, Puducherry, is pleased to approve the aforesaid proposal and for the said purpose hereby make the following amendments to G.O. Ms. 21/2007-Ind.C., dated 24-03-2008 of the Department of Industrial Development (Industries and Commerce), Puducherry and G.O. Ms. No. 01/2009-Ind-C, dated 15-04-2009 of the Department of Industrial Development (Industries and Commerce) Puducherry, namely:-

In the Annexure to the aforesaid Government Order's the following amendments shall be made.

I. NAME OF THE SCHEME: **DEVELOPMENT OF HANDICRAFTS**

A. Training

In sub clause (i), (ii) (a) (b) of clause (5), the following amendments shall be made.

5. Pattern of Assistance

<i>Clause</i>	<i>For</i>	<i>Read</i>
(i) Stipend to the trainees.	₹ 1,500 per month/ per trainee.	₹ 4,500 per month/ per trainee.
(ii) To the training institution:		
(a) Honorarium	₹ 300 per month/ per trainee (max ₹ 3,000 per month).	₹ 900 per month/ per trainee (max ₹ 9,000 per month).
(b) Compensation wastage of raw materials.	₹ 150 per month/ per trainee (max ₹ 1,500 per month).	₹ 450 per month/ per trainee (max ₹ 4,500 per month).

III. SCHEME: DEVELOPMENT OF COIR INDUSTRIES

A. Training

In sub clause (i), (ii) of clause (4), the following amendments shall be made.

4. Pattern of Assistance

<i>Clause</i>	<i>For</i>	<i>Read</i>
(i) To the trainees-stipend.	₹ 1,500 per month/ per trainee.	₹ 4,500 per month/ per trainee.
(ii) To the trainer:		
(i) Honorarium	₹ 300 per month/ per trainee (max ₹ 3,000 per month).	₹ 900 per month/ per trainee (max ₹ 9,000 per month).
(b) Compensation for wastage of raw materials.	₹ 200 per month/ per trainee (max ₹ 2,000 per month).	₹ 600 per month/ per trainee (max ₹ 6,000 per month).

B. Advanced/High Skilled Trainig

In sub clause (i) & (ii) of clause (4), the following amendments shall be made.

4. Pattern of Assistance

<i>Clause</i>	<i>For</i>	<i>Read</i>
For Trainees:		
(i) Stipend per trainee.	₹ 2,500 per month/ per trainee.	₹ 7,500 per month/ per trainee.
(ii) Accommodation charge.	₹ 500 per month/ per trainee.	As prescribed by the training institutions.

IV. NAME OF THE SCHEME: **TRAINING****A. In-Plant Training: (Industries & Service Oriented)**

In sub clause (i) & (ii) of clause (5), the following amendments shall be made.

5. Pattern of Assistance

<i>Clause</i>	<i>For</i>	<i>Read</i>
(I) Stipend to the trainees:		
(i) SSLC/ITI/H.S.C. trainees.	₹ 1,500 per month/ per trainee.	₹ 4,500 per month/ per trainee .
(ii) Graduate/Diploma in Engineering or equivalent.	₹ 2,500 per month/ per trainee.	₹ 7,500 per month/ per trainee.
(iii) Degree in Engineering/ Postgraduate in Science or equivalent.	₹ 3,000 per month/ per trainee.	₹ 9,000 per month/ per trainee.
(I) To the Training Institution:	During the training period the trainees may waste some of the raw materials for which an amount up to ₹ 300 per trainee/per month will be paid to the industry which imparts the training as compensation for wastage of raw materials.	During the training period the trainees may waste some of the raw materials for which an amount up to ₹ 900 per trainee/per month will be paid to the industry which imparts the training as compensation for wastage of raw materials. (Not applicable to the trainees sponsored to Government Department and their Agencies).

C. Advanced/High Skilled Training

In sub clause (II) of clause (3), the following amendments shall be made.

3. Pattern of Assistance

<i>Clause</i>	<i>For</i>	<i>Read</i>
For Trainees:		
(i) Stipend :		
(a) up to HSC/ITC, etc.,	₹ 2,500 per month/ per trainee.	₹ 7,500 per month/ per trainee.
(b) For Degree/ Diploma holders (3 years)/ Postgraduate.	₹ 3,000 per month/ per trainee.	₹ 9,000 per month/ per trainee.

5. These amendments shall be made with effect from 1st April 2023.
