ORDER

Whereas, Thiru P. Veerappan, s/o. Patchaiyappan former Wireman, 110/22 K.V. Sub-station, Office of the Executive Engineer Rural (South) O&M, Electricity Department, Puducherry, was dismissed from Government Service with effect from 24-01-2020 *vide* Order No. 1572/EE/EE-R(S)/Estt./A7/2020, dated 24-01-2020 of the Executive Engineer, Rural (South) O&M, Electricity Department, Puducherry, consequent to the conviction on a criminal charges under section 323 of IPC with a fine of ₹ 1,000 and in default to undergo simple imprisonment for two weeks for the offences against him as pronounced by the Hon'ble Judicial Magistrate Court, Yanam *vide* their judgment, dated 17-04-2018 in CC No. 32/2010;

And whereas, Thiru P. Veerappan has filed an appeal petition on 06-03-2020 against the dismissal order before the Secretary (Power)-*cum*-Appellate Authority. The Secretary to Government (Power)-*cum*-Appellate Authority, after examining his plea in detail, dismissed his appeal stating that the dismissal order, dated 24-01-2020 issued by the Executive Engineer-Rural (South) fulfills the requirements of laws and the appeal was devoid of merits;

And whereas, Thiru P. Veerappan has filed an appeal before the Hon'ble III-Additional Sessions Judge at Puducherry in C.A.No. 22/2018 and the Hon'ble Court has set aside the Trial Court order of the conviction and sentence on 28-10-2021 and ordered to refund the fine amounts. He was therefore acquitted in the criminal case;

And whereas, there is no appeal has been preferred by the Prosecution side against the Judgment, dated 28-10-2021 of the Hon'ble III-Additional Session Judge at Puducherry in C.A.No. 22/2018 as per the Letter No. 120/YPCR/LDR/2023, dated 20-03-2023 of the Sub-Inspector of Police, PCR Cell, Yanam and the Law Department opinioned that it is open to Competent Disciplinary Authority to take a decision regarding reinstatement of Thiru P.Veerappan into Government Service in view of the Judgment by the Hon'ble Supreme Court of India in Ajit Kumar VGM,(PJ) Indian Oil

Corporation Limited, (2005) 7SCC764 and R.P. Kapur vs. Union of India and another (AIR 1964 SC 787) (a Five Judge Bench Judgment) and as per Government of India Decision No. (5) below rule 19 of the CCS (CCA) Rules, 1965;

Now, therefore, the undersigned being the Disciplinary Authority based on the pronouncement of the Hon'ble III-Additional Sessions Judge at Puducherry and taking the provisions of Government of India Decision No. 5 below rule 19 of the CCS (CCA) Rules, 1965 ordered for him reinstatement in Government Service along with consequential service benefits.

Ms. No. 1/CHRI/T.2/2023, dated 14-07-2023, and in exercise of the powers conferred under the Puducherry Hindu Religious Institutions Act, 1972, Thiru P. Vinod, s/o. Pachaiyappan, Primary School Teacher, Government Primary School, Alankuppam, Zone-I, Education Department, Puducherry, is hereby appointed as Temple Administrative Officer of Arulmigu Sri Muthumariamman Thirukoil, Chinna Kuyavarpalayam, Oulgaret Municipality, Puducherry, on honorary basis. The Temple Administrative Officer shall administer the said Devasthanam as envisaged in the provisions of the Puducherry Hindu Religious Institutions Act, 1972 and the rules framed thereunder.

Important duties and responsibilities of the Temple Administrative Officer are given below

(v) Submission of annual budget by March as per rule 13 of the Act;

(vi) To maintain accounts as per sections 14 to 17 of Hindu Religious Institutions Act and to get the accounts, audited annually by the Directorate of Accounts and Treasuries, Puducherry;

(vii) Shall ensure that the Poojas and Festivals are conducted according to the customs followed by the Devasthanam;

(viii) Shall collect all debts and funds due to the Institution and secure them from the loss or risk of loss;

(ix) Shall ensure that appropriate proceedings are instituted to effect all debts and funds due to the Institution or recovery thereof and also to defend such action against the Institution in respect of the property of the Institution;

(x) Shall not connive at or facilitate any act or conduct of another person which would involve a breach of trust or occasion risk or loss to the property belonging to the Institution;

(xi) Shall strictly conform to and carry out the terms and shall not encumber the properties of the Institution by persistently incurring expenditure beyond the limits of the income of the property of the Institution;

(xii) Shall not in any way make use of the property of the Institution or of his position as Temple Administrative Officer, for his self-interest or private advantage; and shall be personally responsible for the exercise of his judgment and for performance of his duty and he cannot, therefore, escape responsibility by leaving to another person the exercise of judgment or the performance of that duty.

Under sub-section (2) of section 4 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

Whereas, certain lands are required for the public purpose viz., "Formation of link road south of Puducherry - Villupuram Railway - By-passing of Arumparthapuram - Natesan Nagar segment of NH-45A" at 41 - Olandai and 36 - Reddiyarpalayam Revenue Villages of Puducherry District;
