#### **NOTIFICATION**

Whereas, the proposal for Constitution of Judicial Magistrate-*cum*-District Munsif Court at Yanam and creation of various posts for the proposed Court has been initiated based on the recommendations and approval of the Hon'ble High Court of Judicature at Madras *vide* R.O.C.No. 15259/2016/Pondy, dated 04-05-2016 of Hon'ble High Court of Madras and in compliance to the Order, dated 21-03-2022 of the Hon'ble Supreme Court of India in Writ Petition No. 1022 of 1989 filed by All India Judges Association.

2. And whereas, the details of various posts, as proposed by the Chief Judge, Puducherry, for constitution of the abovesaid New Court, are as detailed below:-

- 3. And whereas, the Department of Expenditure, Ministry of Finance, Government of India *vide* Office Memorandum No. 7 (2)/E.Coord./2013, dated 18th September, 2013 has imposed a total ban on the creation of Plan and Non-Plan posts. In view of the ban imposed by the Government of India, the proposals relating to Constitution of Judicial Magistrate-*cum*-District Munsif Court at Yanam and creation of various posts for the said Court requires sanction of the Ministry of Home Affairs, Government of India.
- 4. And whereas, the Finance Department, Puducherry, has approved the abovesaid proposal for taking up with the Department of Justice, Ministry of Law and Justice, Government of India, through Ministry of Home Affairs, New Delhi. The approval of the Hon'ble Chief Minister and the Hon'ble Lieutenant-Governor, Government of Puducherry, have also been obtained in the abovesaid proposal before referring the same to the Government of India.
- 5. And whereas, the proposal was taken up with the Government of India *vide* Letter No. 1572/2016-LD., dated 03-08-2016 of Law Department, Puducherry.
- 6. And whereas, *vide* Letter No. L-18020/11/2016-Jus.I, dated 09-09-2016 and 12-06-2017 of Ministry of Law and Justice, Government of India and Letter No. L-18020/8/2016-Jus.I, dated 31-10-2016, 19-05-2017, 20-04-2018, 22-05-2019, 04-09-2020 and 04-04-2022 of Ministry of Law and Justice, Government of India, the Department of Justice, Ministry of Law and Justice has requested for various information's/clarifications for Constitution of Judicial Magistrate-*cum*-District Munsif Court at Yanam and creation of various posts for the said Court, and necessary information's/clarifications as requested were submitted to the Ministry *vide* Letter No. 1572/1/2016-LD., dated 20-09-2016 of Law Department, Puducherry, and Letter No. 1572/2016-LD., dated 03-08-2016, 20-09-2016, 16-02-2017, 12-12-2017, 20-06-2018, 11-07-2019, 18-11-2019, 30-12-2020, 15-03-2022, 13-04-2022, 21-12-2022 of Law Department of Government of Puducherry.
- 7. And whereas, *vide* Letter No. L-18020/08/2016-Jus.I, dated 24-07-2023 of the Ministry of Law and Justice, Government of India, the Department of Justice, Ministry of Law and Justice, Government of India, has conveyed sanction for creation of the following 17 posts in Judicial Department, Government of Puducherry, for constitution of New Judicial Magistrate-*cum*-District Munsif Court, Yanam, with the concurrence of Department of Expenditure, Ministry of Finance [*vide* I.D.No. 11(1)/DoJustice/2023/E.Coord.I, dated 14-07-2023].
