NOTIFICATION

Whereas, the proposal for creation of 12 posts of supporting staff for the Court of Special Officer-*cum*-Additional Sub Judge-*cum*-Assistant Sessions Judge in the Union territory of Puducherry has been initiated based on the request made by the Judicial Department and in pursuance of the Government Order *vide* G.O. Ms. No. 24/2014-LD., dated 24-07-2014 of the Law Department, Puducherry and Letter No. 787/JD/A/2014, dated 04-09-2014 of the Judicial Department, Puducherry, and in compliance to the Order, dated 21-03-2022 of the Hon'ble Supreme Court of India in Writ Petition No. 1022 of 1989 filed by All India Judges Association.

2. And whereas, the details of various posts as proposed by the Judicial Department, Puducherry for the Court of Special Officer-*cum*-Additional Sub Judge-*cum*-Assistant Sessions Judge in the Union territory of Puducherry, is as detailed below:-

3. And whereas, the Department of Expenditure, Ministry of Finance, Government of India *vide* Office Memorandum No. 7 (2)/E.Coord/2013, dated 18th September, 2013 has imposed a total ban on the creation of Plan and Non-Plan posts. In view of the ban imposed by the Government of India, the proposals relating to creation of various posts of supporting staff for the Court of Special Officer-*cum*-Additional Sub Judge-*cum*-Assistant Sessions Judge in the Union territory of Puducherry, requires sanction of the Ministry of Home Affairs, Government of India.

4. And whereas, the Finance Department, Puducherry, has approved the abovesaid proposal for taking up with the Department of Justice, Ministry of Law and Justice, Government of India through Ministry of Home Affairs, New Delhi.

5. And whereas, the proposal was taken up with the Government of India *vide* Letter No. 1827/2014-LD, dated 03-11-2014 of the Law Department, Government of Puducherry.

6. And whereas, *vide* Letter No. U-13034/374/2014-CPD, dated 24-11-2014, of Ministry of Home Affairs, Government of India, the Ministry of Home Affairs had forwarded the proposal to the Ministry of Law and Justice. The Department of Justice, Ministry of Law and Justice has requested for various information's/ clarifications for creation of various posts of supporting staff for the Court of Special Officer-*cum*-Additional Sub Judge-*cum*-Assistant Sessions Judge in the Union territory of Puducherry *vide* Letter No. L-18020/5/2016-Jus.I, dated 26-05-2016, 09-08-2016, 14-12-2016, 12-09-2019, 03-02-2020, 31-03-2022 and 03-10-2022 of Department of Justice, Ministry of Law and Justice, Home Affairs, Government of India, and necessary information's/clarifications as requested were submitted to the Ministry *vide* Letter No. 1827/2014-LD., dated 08-04-2016, 28-06-2016, 09-11-2016, 02-08-2019, 10-01-2020, 30-12-2020, 23-03-2022, 13-04-2022, 18-04-2022 and 12-10-2022 of the Law Department, Government of Puducherry.

7. And whereas, *vide* Letter No. L-18020/5/2016-Jus.I/6936, dated 24-07-2023 of Department of Justice, Ministry of Law and Justice, Home Affairs, Government of India, has conveyed sanction for creation of the following 10 posts of supporting staff for the Court of Special Officer-*cum*-Additional Sub Judge-*cum*-Assistant Sessions Judge in the Union territory of Puducherry, with the concurrence of Department of Expenditure, Ministry of Finance (*vide* I.D.No. 11(3)/DoJustice/2023/ E.Coord.I, dated 14-07-2023).
