**NOTIFICATION**

The Lieutenant-Governor, Puducherry, is pleased to enhance the quantum of assistance under the Scheme component "Grant of input subsidy to fish farmers in the Union territory of Puducherry" under the Scheme "Development of Freshwater Aquaculture and Setting up of Aquarium, Ornamental Fish Breeding Centre" and for the said purpose hereby makes the following Amendments to the notification issued vide G.O. Ms.No. 8/Fy, dated 28-03-2008 of the Chief Secretariat (Fisheries), Puducherry, and subsequent Amendment issued vide G.O. Ms. No. 11/Fy., dated 04-06-2019 of the Under Secretary to Government (Fy), Chief Secretariat (Fisheries), Puducherry (hereinafter referred to as the said Scheme), namely:-

## AMENDMENT

(I) In the said Scheme for clause 9, the following shall be substituted, namely:-

9. "Pattern of assistance":- The input subsidy shall be:

(a) @ ₹ 8,500 per acre restricted to 5 acres per year to the general public who are undertaking freshwater fish culture with effect from the date of issue of this order.

2. The other terms and conditions remain unaltered.

3. This issues with the concurrence of the Finance Department, Puducherry, *vide* their I.D. No. 316/FC/FD/F3/A4/2023-24, dated 19-07-2023.
