NOTIFICATION

Whereas, the Government of Puducherry appointed the Officer on Special Duty/Director and Senior Analyst (Senior Scientist) as Chemical Examiner and Assistant Chemical Examiner respectively, for the purpose of section 293 of Criminal Procedure Code 1973 (Central Act 2 of 1974) for the Government of Puducherry, in respect of the Forensic Science Laboratory, Puducherry, with Units such as Biology/Serology Divisions, for conducting the chemical analysis of the crime exhibits in the year 2013.

And whereas, the Government of Puducherry approved to undertake the chemical analysis of the crime exhibits relating to Biology/Serology Divisions referred to them by the Courts concerned in the Union territory of Puducherry and for examining the crime exhibits and dispatch the findings/expert opinion in the year 2015.

And whereas, the Government of Puducherry has approved to start the additional Units such as DNA Unit, Chemical Sciences Division (Toxicology Unit/ Narcotics Unit/Chemistry Unit), Physical Sciences Division (Cyber Forensic Unit and Questioned Document Unit) with minimum requisite manpower and infrastructure in the year 2020.

And whereas, the Government of Puducherry has permitted to receive case exhibits related to DNA Unit for examination and report from 23-01-2024.

And whereas, a proposal was submitted by the Forensic Science Laboratory, Puducherry, to declare Thiru Kartik Rana, Analyst-Scientist in DNA Division also as Assistant Chemical Examiner for DNA Division in the Forensic Science Laboratory, Puducherry.

Now, therefore, the Lieutenant-Governor, Puducherry, is hereby pleased to appoint Thiru Kartik Rana, Analyst-Scientist in DNA Division, Forensic Science Laboratory, Puducherry, also as Assistant Chemical Examiner for the purpose of section 293 of the code of Criminal Procedure, 1973 (Central Act 2 of 1974) for the Government of Puducherry, with immediate effect.
