ORDER

(UNDER SECTION 144 OF Cr.P.C.)

To

Thiru Loganathan (65),
S/o. Sarangapani,
No. 10, North Street,
Mangalam,
Puducherry.

Whereas, it has been made to appear to me that you have trivial and scant respect to the judiciary and rule of law, and involved in various offences against public tranquility, offences affecting property and human body and that you have become a perennial source of threat to the community, public peace and order;

And whereas, I am convinced of your involvement in a criminal cases mentioned hereunder–

1. Cr.No. 111/2005 under sections 143, 435 r/w 149 IPC of Villianur Police Station, Puducherry.
2. Cr.No. 156/2011 under sections 147, 148, 341, 427 IPC r/w 149 IPC of Mangalam Police Station, Puducherry,
3. Ir.No. 146/2006 under section 107 Cr.P.C. of Villianur Police Station, Puducherry.
4. Ir.No. 188/2008 under section 107 Cr.P.C. of Villianur Police Station, Puducherry.
5. Ir.No. 18/2024 under section 107 Cr.P.C. of Mangalam Police Station, Puducherry.

and your vengeful acts along with your accomplices against your opponents have created panic in the minds of the people;

And whereas, the Station House Officer, Mangalam Police Station, Puducherry, has filed a case against you *vide* IR.No. 26/2024 under section 144 of Cr.P.C., dated 08-02-2024. It is stated by the Station House Officer, Mangalam Police Station, Puducherry, that you are disturbing the public peace and order which has created panic in the minds of local inhabitants in the Mangalam Village;

And whereas, summons were served for your appearance on 29-02-2024, 21-03-2024 and 01-04-2024 to file your explanation/objection as to why the Subdivisional Magistrate (South), Villianur, Puducherry, should not order to prevent you from entering into the south region under section 144 (3) of Cr.P.C. and you have appeared and put forth your side, which is unconvincing;

And whereas, during the Court proceedings, the petitioner stated that the Counter Petitioner is involved in a temple dispute and is creating rumours regarding temple construction and the Counter Petitioner has denied all the statements made by the petitioner. In this regard, the Tahsildar, Villianur Taluk, was asked to conduct a discreet enquiry on the above issue. The Tahsildar, Villianur, report states that recently, Enjolai Mariamman Temple was completely demolished for its reconstruction. The Counter Petitioner Thiru Loganathan, son of Sarangapani has developed unrest in the area by spreading rumours and incineration;

And whereas, based on the report laid before me, I am of the opinion that if, you are allowed to reside within the limits of this jurisdiction, you will continue to indulge in and disturbance to the public tranquility and order, *etc.*, and thereby become a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C., is invoked to take action against you to prevent harm to life and properties of citizens and uphold public peace and order; your presence is a threat to public tranquility in Puducherry District and therefore, an immediate action is required for curtailing your illegal activities in the locality;

Now, therefore, based on the reasons stated above, I Soma Sekhar Apparao Kotaru, Subdivisional Magistrate (South), Villianur, Puducherry, in exercise of the powers conferred under Code of Criminal Procedure, do hereby prohibit you under section 144 of Cr.P.C., from entering into the Subdivisional Magistrate Court (South), Jurisdiction for one month from the date of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry. However, you may appear either in person or by Pleader before the undersigned to represent against the order.
