NOTIFICATION

The Government of Puducherry, in consultation with the High Court of Judicature at Madras, hereby designates the Principal District Court at Puducherry for Sessions Division of Puducherry and Karaikal as the Special Courts in the Union territory of Puducherry and also appoints the Principal District and Sessions Judge as the Judge of the said Special Court to try all the criminal cases including sessions cases and cases arising from (i) Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 (Central Act 33 of 1989); (ii) Protection of Children from Sexual Offences (POCSO) Act, 2012 (Central Act 32 of 2012); (iii) Exclusive Trial of Cases of Offences against Women; (iv) Prevention of Corruption Act, 1988 (Central Act 49 of 1988); (v) Communal Clash Cases; (vi) Bomb Blast Cases; and (vii) Land Grabbing Cases, as well as cases under the Special Acts, Central Acts and State Acts, involving elected Members of Parliament and Members of Legislative Assembly of the Union territory of Puducherry.
