Therein, it has been stated that the Counter Petitioner have formed a gang of rowdies and indulging in crime such as murder, attempt to murder, extortion by using lethal weapons. The Counter Petitioner has created panic in the minds of local inhabitants. It is also stated that he is leading lavish life with the money earned through extortion. As a result, the people of the locality being afraid of the Counter Petitioner do not come forward to lodge any complaint against him. It is also stated that even witnesses don't come forward voluntarily to give evidence against him in the cases where he is the accused. In this connection, the Petitioner had stated that the following criminal cases were registered against the Counter Petitioner.

- 4. The Petitioner further stated that the Counter Petitioner has involved in various body offences by using arrayal, knife to attack the victims and become a source of terror among the public. It is also stated that the Counter Petitioner violated the conditions imposed by the Criminal Courts and has scant respect to the judiciary and rule of law.
- 5. The Petitioner further submitted that if the Counter Petitioner is allowed to reside in Puducherry urban limits, it is apprehended that he would continue to indulge in serious offences like murder, extortion, assault, obstructions and annoyance, damages to public and private properties, and thereby emerged as a perennial source of threat to the community and disturb public peace and tranquility. Hence, the Station House Officer, D'Nagar Police Station, Puducherry, has prayed to invoke provisions under section 144 of Cr.P.C., against the Counter Petitioner to not to enter into the jurisdiction of this Court for a period of two months as to prevent danger to the human life and properties and disturbance to the public tranquility and order.

- 6. The proceeding was started by affording an opportunity to the Counter Petitioner to show cause against the petition filed by the Petitioner. A notice was served to both the parties on 21-03-2024 to appear for the hearing on 02-04-2024 at 10.00 a.m. It was instructed to serve the notice to the Counter Petitioner through the Station House Officer, D'Nagar Police Station, Puducherry. The notice for the Counter Petitioner was received by his mother. The service was held sufficient for the Counter Petitioner.
- 7. On 02.04.2024 at 10.00 a.m. the Petitioner, represented by Thiru Vengadesan, Sub-Inspector of Police, D'Nagar Police Station, Puducherry and the Counter Petitioner were present.
- 8. I have heard both the sides and carefully gone through all the available records placed before me. In the Police Information Report/Petition, it is stated that the activities of Thiru Honest @ Honestraj (24), is in such a manner that he may cause breach of peace and create a problem of law and order and public tranquility. He has involved in crimes such as murder, assault, unlawful activities and disturbance to the public peace and order. There are 5 criminal cases were registered against him in various Police Stations. I have also heard the oral submission of the Counter Petitioner. The Counter Petitioner has stated that the Petitioner has filed this false case with an ulterior motive.
- 9. Upon hearing both sides and on perusal of the records submitted by the Petitioner and the recommendation of the Superintendent of Police (North), I am of the opinion that if the Counter Petitioner is allowed to reside within the limits of my jurisdiction, the Counter Petitioner will continue to indulge in and also motivate serious offences like murder, assault, damages to public and private properties, obstructions, annoyance, *etc.*, and thereby become a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence it is necessary that special provision under section 144 of Cr.P.C., is invoked to take action against the Counter Petitioner to prevent harm to life and properties of citizens and uphold public peace and order.
- 10. Hence, I, Arjun Ramakrishnan, do hereby in the capacity of Subdivisional Magistrate (North), Puducherry, in exercise of powers conferred under section 144(1) of the Code of Criminal Procedure, pass this order and prohibit the Counter Petitioner Thiru Honest @ Honestraj (24), son of Chandaramass, a resident of No. 4, Manthoppe, Veeman Nagar, Thilaspet, Puducherry, from entering into the region under the jurisdiction of the Subdivisional Magistrate Court (North), for a period of 20 days from the date of this order (in view of the GELS-2024) or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry.

- 2. The Counter Petitioner is Thiru Vicky @ Vellai Vicky @ Vigneshwaran (26), son of Manoharan, No. 4, Mullai Street, Kamaraj Nagar, Gorimedu, Puducherry.
- 3. The facts which led up to the petition are briefly as follows: The case submitted by the Station House Officer, D'Nagar Police Station, Puducherry, through the Superintendent of Police (North), Puducherry vide I.R. No. 84/2023 under section 144 of Cr. P.C., dated 11-12-2023. Therein it has been stated that the Counter Petitioner have formed a gang of rowdies and indulging in crime such as murder, attempt to murder, extortion by using lethal weapons. The Counter Petitioner has created panic in the minds of local inhabitants. It is also stated that he is leading lavish life with the money earned through extortion. As a result, the people of the locality being afraid of the Counter Petitioner do not come forward to lodge any complaint against him. It is also stated that even witnesses don't come forward voluntarily to give evidence against him in the cases where he is the accused. In this connection, the Petitioner had stated that the following criminal case was registered against the Counter Petitioner.
  - Cr.No. 293/2020 under sections 302 r/w 34 IPC @ 147, 148, 302 r/w 149 IPC., dated 30-09-2020 of D' Nagar Police Station, Puducherry.
- 4. The Petitioner further stated that the Counter Petitioner has involved in various body offences by using arrayl, knife and explosive substances to attack the victims and become a source of terror among the public. It is also stated that the Counter Petitioner violated the conditions imposed by the Criminal Courts and has scant respect to the judiciary and rule of law.
- 5. The Petitioner further submitted that if, the Counter Petitioner is allowed to reside in Puducherry urban limits, it is apprehended that he would continue to indulge in serious offences like murder, extortion, assault, obstructions and annoyance, damages to public and private properties, and thereby emerged as a perennial source of threat to the community and disturb public peace and order. Hence, the Station House Officer, D'Nagar Police Station, Puducherry, has prayed to invoke provisions under section 144 of Cr.P.C., against the Counter Petitioner to not to enter into the jurisdiction of this Court for a period of two months as to prevent danger to the human life and properties and disturbance to the public tranquility and order.
- 6. The proceeding was started by affording an opportunity to the Counter Petitioner to show cause against the petition filed by the Petitioner. A notice was served to both the parties on 21-03-2024 to appear for the hearing on 02-04-2024 at 10.00 a.m. It was instructed to serve the notice to the Counter Petitioner through the Station House Officer, D'Nagar Police Station, Puducherry. The notice for the Counter Petitioner was received by his mother, Tmt. Krishnaveni. The service was held sufficient for the Counter Petitioner.
- 7. On 02-04-2024 at 10.00 a.m. the Petitioner, represented by Thiru Vengadesan, Sub-Inspector of Police, D'Nagar Police Station, Puducherry, and the Counter Petitioner were present.
- 8. I have heard both the sides and carefully gone through all the available records placed before me. In the Police Information Report/Petition, it is stated that the activities of Thiru Vicky @ Vellai Vicky @ Vigneshwaran (26), is in such a manner

that he may cause breach of peace and create a problem of law and order and public tranquility. He has involved in crimes such as murder, unlawful activities and disturbance to the public peace and order. There is one criminal case was registered against him in D'Nagar Police Station, Puducherry. I have also heard the oral submission of the Counter Petitioner. The Counter Petitioner has stated that the Petitioner has filed this false case with an ulterior motive.

- 9. Upon hearing both sides and on perusal of the records submitted by the Petitioner and the recommendation of the Superintendent of Police (North), I am of the opinion that if, the Counter Petitioner is allowed to reside within the limits of my jurisdiction, the Counter Petitioner will continue to indulge in and also motivate serious offences like murder, assault, damages to public and private properties, obstructions, annoyance etc., and thereby become a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C., is invoked to take action against the Counter Petitioner to prevent harm to life and properties of citizens and uphold public peace and order.
- 10. Hence, I, Arjun Ramakrishnan, do hereby, in the capacity of Subdivisional Magistrate (North), Puducherry, in exercise of powers conferred under section 144(1) of the Code of Criminal Procedure, pass this order and prohibit the Counter Petitioner Thiru Vicky @ Vellai Vicky @ Vigneshwaran (26), son of Manoharan, No. 4, Mullai Street, Kamaraj Nagar, Gorimedu, Puducherry, from entering into the region under the jurisdiction of the Subdivisional Magistrate Court (North) for a period of 20 days from the date of this order (in view of the GELS 2024) or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry.
