NOTIFICATION

These Rules may be called as the "Chief Minister's Scheme for Grant of Subsidy for LPG Cylinder" to all the BPL and APL Family Ration Cardholders of Union territory of Puducherry (Amendment) Rules, 2024.

2. The following paras shall be substituted/inserted below the Serial Number 3, 5 and 6 respectively, in the Notification to the G.O. Ms. No. 1, dated 06-07-2023 of this Department, as below:-

3(p) "Eligible beneficiaries" mean, the resident of Puducherry who possess a Family Ration Card (excluding Honorary/Green Cards) having Domestic Gas connection and who register their details such as Consumer number, Gas Agency name, Mobile number, Aadhaar Card number and Family Ration Card number through the following website and mobile App linked through LPG Consumer number and Mobile number through Mobile App or the website verified by the Department of Civil Supplies and Consumer Affairs, Puducherry, and have produced their Aadhaar Number.

- 5. Nature of Assistance:- Each BPL Family Ration Cardholders shall be granted the subsidy amount of ₹ 300 per month per 14.2 kg. cylinder and each APL Family Ration Cardholders shall be granted the subsidy amount of ₹ 150 per month per 14.2 kg. cylinder for 12 LPG cylinders of 14.2 kg per year from the date of registering Aadhaar Number and on the basis of monthly delivery data obtained from Gas Agencies through Nodal Officer. This list shall contain only active cylinder consumers as updated every month to the extent of one LPG cylinder per month and limited to actual use. All inactive/surrenders/transfer cylinder customers will be deleted/updated every month as per the certified list of BPL/APL Gas Consumers shared by the Gas Companies/Nodal Agencies, *i.e.*, Indian Oil Corporation (IOC).
- 6(i) Mode of Disbursement:- The beneficiaries are identified by the Department of Civil Supplies and Consumer Affairs on the factor that who are registering their details up to 31-03-2024 will be eligible to receive the subsidy amount of ₹ 300 per month per 14.2 kg. cylinder for BPL Family Ration Cardholders and subsidy amount of ₹ 150 per month per 14.2 kg. cylinder for APL Family Ration Cardholders for 12 LPG cylinders of 14.2 kg. per year with effect from 12-07-2023 *i.e.* from the date of publication in G.O. Ms. No. 1, dated 06-07-2023 in the Extraordinary Gazette of Puducherry, Part-II No. 57, dated 12-07-2023.

- (ii) The beneficiaries who are registering their details beyond the date, *i.e.*, 31-03-2024 will be considered for grant of Subsidy amount of ₹ 300 per month per 14.2 kg. cylinder for BPL Family Ration Cardholders and subsidy amount of ₹ 150 per month per 14.2 kg. cylinder for APL Family Ration Cardholders for 12 LPG cylinders of 14.2 kg. per year from the date of registration of the respective month only.
 - 3. All other Terms and Conditions remain unaltered.
