This case coming on this day before us in the presence of the Petitioner and his Counsel Thiru P. Sankaran, and the respondent, and his Counsel Thiru R. Ilancheliyan, having agreed to settle the matter and thereby the case being settled under Joint Compromise Memo filed along with 18(1) Settlement, an Award is passed accordingly:

Taken Cognizance under section 20(1) of the Legal Services Authorities Act (Act 39/87)

1. This case which was filed and pending before the Presiding Officer as ID(L).No.24/2019 was transferred to the Lok Adalat and was taken for Settlement.

2. The petitioner has filed this case to pass an Award to hold that the non-employment and non-payment of salary dues from the date of transfer *i.e.*, 02-02-2017 of the petitioner/workman by the respondent/management is not justified and for other monetary benefit, if any.

3. Both parties appeared before the Lok Adalat Pre-negotiation sitting on 15-06-2022 and the petitioner and the respondent jointly filed a Compromise Memo stating that the respondent/management will withdraw the transfer order.

4. The Compromise Memo and the Settlement under section 18(1) of Industrial Disputes Act, 1947 filed by the both parties voluntarily and examined them, satisfied and recorded. Accordingly, the Joint Compromise Memo and the Settlement under section 18(1) of Industrial Dispute Act, 1947, filed by the both parties, are recorded and an Award is passed under the terms and conditions therein.

5. This case is referred to the Lok Adalat organized by the State Legal Services Authority under section 19 of the Legal Services Authorities Act (Act 39/87) and after full and frank discussion of all issues, an Award is passed as follows:

AWARD

1. It is ordered and declared that the Award is passed in terms of the Joint Compromise Memo and the Settlement under section 18(1) of Industrial Disputes Act, 1947 made by both the parties and that the reference made by the Government on G.O. Rt. No. 70/AIL/Lab./T/2019, dated 03-05-2019 and the reference is hereby closed. The Joint Compromise Memo and the Settlement under section 18(1) of Industrial Disputes Act, 1947 shall form part and parcel of the Award.

2. That this Award of the Lok Adalat shall be deemed to be a Decree of the Civil Court as per section 21 of the Legal Services Authorities Act, 1987.
