IN THE COURT OF SUBDIVISIONAL MAGISTRATE (SOUTH) AT VILLIANUR

ORDER

(UNDER SECTION 163(3) BNSS, 2023)

To

Thiru Murugavel @ Murugan (39), S/o. Balu, No. 39, Mariamman Koil Street, Manapet Road, Kanniakoil, Puducherry.

Whereas, it has been made to appear before me that you have trivial and scant respect to the judiciary and rule of law and are involved in various offences against public tranquility, offences affecting property and human body and that you have become a perennial source of threat to the community, public peace and order;

And whereas, I am convinced of your involvement in various criminal cases as under-

- 2. Cr. No. 67/2022 under sections 294(b), 324, 506 (ii) r/w 34 IPC, dated 16-08-2022.
- 3. Cr. No. 42/2024 under sections 341, 294(b), 323, 506 (i) r/w 34 IPC, dated 23-04-2024.
- 4. Cr. No. 74/2024 under sections 294(b), 323, 506 (i) r/w 34 IPC, dated 12-06-2024.
- 5. Cr. No. 08/2023 under section 34(B) (ix) of PP Act.
- 6. IR No. 39/2023 under sections 150, 107 Cr. P.C.

and your vengeful acts along with your accomplices against your opponents have created panic in the minds of the people;

And whereas, the Station House Officer, Kirumampakkam Police Station, Puducherry, has filed a case against you *vide* IR.No. 57/2024 under section 144 of Cr.P.C., dated 12-06-2024. It is stated by the Station House Officer, Kirumampakkam Police Station, Puducherry that you are indulging in crime such as hurt, murder, extortion and disturbance to the public tranquility and order, and you have created panic in the minds of local inhabitants. It is also stated that you have become a source of terror among the public;

And whereas, the Station House Officer, Kirumampakkam Police Station, Puducherry, further, submitted that if, you are allowed to reside in Subdivisional Magistrate (South) jurisdiction limits, it is apprehended that you would continue to indulge in serious offences like threatening the public, mischief and hurt case, attempt to murder and disturbance to the public tranquility and order *etc.*, and thereby emerged as a perennial source of threat to the community and disturb public peace and order;

And whereas, summons were served for your appearance on 11-07-2024 and 07-08-2024 to file your explanation/objection as to why the Subdivisional Magistrate (South), Villianur, Puducherry, should not order to prevent you from entering into the south region under section 163(3) of BNSS and you have failed to appear before this Court and hence, the case is decided *ex parte* under section 163(2) of BNSS in the view of urgency of the matter.

And whereas, based on the report laid before me, I am of the opinion that if, you are allowed to reside within the limits of this jurisdiction, you will continue to indulge in and also motivate serious offences and disturbance to the public tranquility and order etc., and thereby become a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 163 of BNSS is invoked to take action against you to prevent harm to life and properties of citizens and uphold public peace and order, your presence is a threat to public tranquility in Puducherry District and therefore, an immediate action is required for curtaining your illegal activities in the locality;

Now, therefore, based on the reasons stated above, I, Soma Sekhar Apparao Kotaru, I.A.S., Subdivisional Magistrate (South), Puducherry, in exercise of powers conferred under Code of Criminal Procedure, do hereby prohibit you under section 163(3) of BNSS from entering into the Subdivisional Magistrate Court (South) jurisdiction for two months from the date of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry. However, you may appear either in person or by Pleader before the undersigned to represent against the order.
