In partial modification of the G.O. Ms. No. 123, dated 18-12-2014 of the Chief Secretariat (Education), Puducherry, the Lieutenant-Governor, Puducherry, is pleased to further amend "The Pondicherry Private Professional Educational Institutions (Provision of Reservation, Admission of Students and Fixation of Fees) Regulations, 2006" (hereinafter referred to as the Principal regulation), notified vide G.O. Ms. No. 63, dated 25-05-2006 of the Chief Secretariat (Education), Puducherry and published in the Gazette No. 24, dated 13th June, 2006 of Puducherry, so as to provide for the reconstitution of the Fee Committee constituted for the purpose of fixing the fee structures and overseeing the admission process in various Unaided Private Professional Colleges of the Union territory of Puducherry, namely:-

#### AMENDMENT REGULATIONS

- 1. Short title and commencement.— (1) These regulations may be called the Puducherry Private Professional Educational Institutions (Provisions of Reservation, Admission of Students and Fixation of Fees) (Second Amendment) Regulations, 2024.
- (2) These regulations shall come into force with effect from the date of their publication in the Official Gazette.
- 2. Amendment of Regulation 4 of Principal Regulation.— The composition of the Fee Committee prescribed in regulation 4 of the Principal regulation, subsequently amended in the G.O. Ms. No. 123, dated 18-12-2014 of the Chief Secretariat (Education), Puducherry, shall stand modified to the following extent:-

#### The composition of Fee Committee for Medical Courses

- (a) A retired Judge of High Court, Madras . . Chairman (to be nominated by the Chief Justice, High Court of Judicature at Madras).
- (b) Chartered Accountant (to be nominated by the Chairman).
- (c) A representative of Medical Council . . Member of India in respect of Health Medical Education.
- (d) Director (Health), Puducherry. . . Member

- (e) Secretary to Government (Health), ... Member-Puducherry. Secretary.
- 3. All other regulations stipulated in the G.Os. read above remain unaltered.
