NOTIFICATION

Whereas, the Draft Rules seeking to amend the Puducherry Factories Rules, 1964, was issued in the Government of Puducherry, Labour Department's Notification under G.O. Ms. No. 06/AIL/Lab/G/2022, dated 31st May 2022 and published as required under sub-section (1) of section 115 of the Factories Act, 1948 (Central Act 63 of 1948),

in the Extraordinary Gazette Part -II, No. 31, dated 12th July 2022 of the Government of Puducherry, inviting objections and suggestions, if any, from all persons likely to be affected thereby;

And whereas, no objection or suggestion has so far been received from any quarter in this regard;

Now, therefore, in exercise of the powers conferred under section 112 of the Factories Act, 1948, the Lieutenant-Governor, Puducherry, hereby makes the following rules further to amend the Puducherry Factories Rules, 1964, namely :-

1. Short title and commencement.— (1) These rules may be called the Puducherry Factories (Amendment) Rules, 2023.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Amendment to rule 4.— In the Puducherry Factories Rules, 1964 (hereinafter, referred to as the said rules), in rule 4, for the existing Schedule thereunder, the following Schedule shall be substituted, namely:

3. Amendment to rule 5.— In the said rules, in sub-rule (3) for the words “fifty rupees”, the words “two hundred rupees” shall be substituted.

4. Amendment to rule 7.— In the said rules, in sub-rule (2) for the words “One hundred rupees”, the words “two hundred rupees” shall be substituted.

5. Amendment to rule 9.— In the said rules, for the words “one hundred rupees”, the words “two hundred rupees” shall be substituted.

6. Amendment to rule 105.— In the said rules, in clause (a) of sub-rule (2-A) for the figures and words “rupees 50 per year per worker”, the figures and words, “rupees 200 per year per worker” shall be substituted.
