NOTIFICATION

The Ministry of Road Transport and Highways (MoRTH), Government of India, New Delhi, in supersession of the Solatium Scheme, 1989 had notified the Scheme namely, "The Compensation to Victims of Hit and Run Motor Accidents Scheme, 2022. As per the said Scheme, there shall be a District Level Committee in each District.

2. In accordance with paragraph 11 of the Compensation to Victim of Hit and Run Motor Accidents Scheme, 2022, read with the Letter, dated 23rd March, 2022 of the Secretary, Ministry of Road Transport and Highways, Government of India, New Delhi, the Government of Puducherry has constituted the District Level Committee for the Puducherry District and Karaikal District under the said Scheme vide G.O. Ms. No. 8/Tr.Sectt./2022, dated 22-08-2022 of the Under Secretary to Government (Transport), Transport Department, Puducherry.

The Lieutenant-Governor, Puducherry, is pleased to approve and reconstitute the "District Level Committee for Compensation to Victims of Hit and Run Motor Accidents Scheme, 2022" with the following Officials/Non-Official Members with immediate effect:

6. Dr. Kumaravel, Regional Medical Officer (Retd.), No. 18, Vengada Nagar, Ariyankuppam, Puducherry-605 007. . . Member (Volunteer)
7. Divisional Manager, Pondicherry Divisional Office, The New India Assurance Company Limited. . . Member-Secretary.

(B) District Level Committee, Karaikal

1. District Collector, Karaikal . . Claims Settlement Commissioner-*cum*-Chairperson
2. Tahsildar, (Karaikal Town/Thirunallar) . . Claims Enquiry Officer-*cum*-Member
3. Superintendent of Police (Traffic), Karaikal . . Member
4. Chief Medical Officer, General Hospital, Karaikal. . . Member
5. Regional Transport Officer, Karaikal . . Member
6. Tmt. Rajeswari, Avvai Village Welfare Society, Karaikal. . . Member (Volunteer)
7. Divisional Manager, Pondicherry Divisional Office, The New India Assurance Company Limited. . . Member-Secretary.

3. Sub/Deputy Collectors shall monitor disposals of Tahsildars and Deputy Tahsildars in their respective Revenue Subdivisions and report to concerned District Collectors.
