## IN THE COURT OF SUBDIVISIONAL MAGISTRATE AT KARAIKAL

Present: Thiru G. Johnson, Subdivisional Magistrate.

> M.C. No. 498/2024, I.R.No. 82/2024/478, dated 12-06-2024

> > PROHIBITORY ORDER

[Under Section 144 (i), (ii) and (iii) of Cr. P.C.]

Whereas, it has been submitted by the Station House Officer, T.R.Pattinam Police Station, Karaikal, that the Counter Petitioners 1 and 2 namely, Ezhilarasi @ Meera (41), daughter of Dharmalingam and Vive @ Vikraman (40), son of Dhanapal residing at Plot Nos. 54 and 55, V Cross Extension, Nethaji Nagar, Karaikal, are notorious rowdy elements who are the perennial source of threat to the community and the Station House Officer has therefore, laid information under section 144 of Cr.P.C.

- 2. The Station House Officer, T.R.Pattinam Police Station, Karaikal, further submits that the counter petitioners being the notorious criminals, does not respect the rule of law, but, rather actively breaks the law. Both the Counter Petitioners had been reportedly indulging in serious offences like organized murders, abetment, extortion, hurt, criminal intimidation. The Station House Officer has also reported that witnesses of their crimes are refusing to volunteer to provide information against them due to fear of retaliation and revenge. The Station House Officer has also reported that the CP-1 and CP-2 had started an organisation named as "SRR Arakkattalai" (எஸ்.ஆர்.ஆர். அறக்கட்டனை) and the same has been functioning with their hooligans and criminal associates at their house. Both of them had been involving in many illegal activities with the money and muscle power (hooligans and criminal associates) within the banner of their above organization.
- 3. The Station House Officer further submits that since the activities of the Counter Petitioners (CP-1 and 2) are detrimental to the public order, it is essential that the CP-1 and 2 are to be restrained immediately from entering in to Karaikal District under the provisions of 144 of Cr.P.C. or else there is likelihood that the Counter petitioners would indulge in wrongful activities while disturbing the public order. Whereas, the Petitioner has submitted that on 11-06-2024 while himself M. Murugan, Sub-Inspector of Police being the Station House Officer, T.R.Pattinam Police Station, Karaikal, was performing rounds within the limits of T.R.Pattinam Police Station, Karaikal Limits, he received reliable information that the Counter Petitioners namely, Ezhilarasi @ Meera and Vive @ Vikraman are likely to create problems in T.R.Pattinam Police Station, Karaikal limits. Further, the Station House Officer, T.R.Pattinam Police Station, Karaikal, stated that reliable information was received about the CP 1 and 2 that they may plan to create a breach of peace and public tranquility in the upcoming Sri Ver Kollai Mariamman Temple fire walk festival (தீ மிதித் திருவிழா) at Polagam, T.R.Pattinam, which has been scheduled to commence from today (12-06-2024) and to culminate on 17-06-2024.
- 4. Whereas, both CP-1 and CP-2 reportedly would attend the said festival amidst the large gathering of devotees during the scheduled dates of various events which will lead to the breach of Law and Order in the locality. The Station House Officer, T.R.Pattinam Police Station, Karaikal, had prayed for orders from this Court to restrain their entry in Karaikal region for a period of 6 (six) months by invoking the provisions under section 144 (i), (ii) and (iii) of Cr.P.C.
- 5. Whereas, I am satisfied that the CP-1 and CP-2 being the habitual offenders, of heinous offences would be detrimental to the maintenance of Law and Order in the area of jurisdiction during the schedule of events connected with the ensuing fire walk festival (த மித்த் தருவழா) of Sri Ver Kollai Mariamman Temple at Polagam, T.R.Pattinam, Karaikal. Whereas, it necessitates to maintain Law and Order, and given the time constraint, serving of notice to the Counter Petitioners as provided under the Code could not be followed and that their activities will endanger human life and properties and the presence of the Counter Petitioners are threat to public tranquility in my Subdivision. Therefore, an immediate action is required for curtailing the illegal activities of the CP-1 and CP-2 in the locality, and whereas, in the view of urgency of matter, this Order is ex parte.

- 6. Hence, I, G. Johnson, Subdivisional Magistrate, Karaikal, after going through the information laid before me and also after satisfying myself of the need for prohibition of certain activities of the both Counter Petitioners, doth hereby pass prohibitory Orders to the Counter Petitioners:-
- (A) Ezhilarasi @ Meera (39), daughter of Dharmalingam and (B) Vive @ Vikraman (40), son of Dhanapal, to restrain both of them from entering into the entire region of Karaikal District which is under the jurisdiction of this Court for a "period of two months from the date of issue of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when they are summoned to attend the cases in any of the Courts in Puducherry and Karaikal.
