NOTIFICATION

In exercise of the powers conferred under section 37 of the Bharatiya Nagarik Suraksha Sanhita, 2023, read with Notification *vide* S.O. No. 2506(E), dated 28-06-2024 of the Ministry of Home Affairs, Government of India, New Delhi, the Lieutenant-Governor, Puducherry, for the purpose of maintaining information about the names and addresses of the person(s) arrested, nature of the offence(s) with which charged and for prominently displaying such information, including by way of digital mode, hereby designates the Police Control Room(s) and the Police Stations and further, designates the Nodal Officers of the said Police Control Room(s) and Police Stations, as under:

(1) The Police Control Room, situated at 3rd floor, Multipurpose Complex, Gorimedu, Puducherry, is notified for the District of Puducherry.

(2) The Central Control Room, SSP Quadrangle, No. 2, Mariamman Koil Street, Karaikal, is notified for the District of Karaikal.

(3) Inspector in-charge of Police Control Room, 3rd floor, Multipurpose Complex, Gorimedu, Puducherry, is designated as the Nodal Officer for the District of Puducherry.

(4) Inspector in-charge of Police Control Room, SSP Quadrangle, No. 2, Mariamman Koil Street, Karaikal, is designated as the Nodal Officer for the District of Karaikal.

(5) The Superintendent of Police, Wireless, 3rd floor, Multipurpose Complex, Gorimedu, Puducherry, shall supervise the work of the Nodal Officers in the Union territory of Puducherry. (6) The Director-General of Police, Puducherry, shall appoint one Police Officer, not below the rank of Assistant Sub-Inspector, as the Designated Police Officer to discharge assigned functions for the purpose(s) of section 37 of Bharatiya Nagarik Suraksha Sanhita, 2023 in every Police Station.

(7) The Designated Police Officer at the Police Station shall be responsible for maintaining information about the names and addresses of the persons arrested and the case for which he/she has been arrested on a daily basis. The said information shall be displayed at the Police Station prominently by modes which may include electronic mode.

(8) The Designated Police Officer of every Police Station shall make available the information maintained by him as above to the Police Control Room(s) of the respective District(s) on a daily basis.

5. Audio/Video Electronic Conferencing (VC) Rooms established in Prisons/ Sub-Jails located in the Puducherry, Karaikal, Mahe and Yanam regions of the Union territory of Puducherry, as designated by the Home Department from time to time.

6. The Forensic Science Laboratory, Kirumampakkam, Puducherry.

7. The Committee Room, Police Headquarters, Puducherry.
