NOTIFICATION

Whereas, the Ministry of Women and Child Development, Government of India, has decided to close the Central Social Welfare Board and has instructed the States/Union Territories for the closure of respective State Social Welfare Boards (SSWBs) by absorbing the Staff into any State Government Schemes, as conveyed *vide* (1) Letter No. 20-2/2021-CSWB, dated 18-06-2021 of the Ministry of Women and Child Development, Government of India, New Delhi,

(2) F.No. CSWB-016/32/2021-CSWB, dated 28-04-2022 of the Ministry of Women and Child Development, Government of India, New Delhi and
(3) F.No. (e-93682)CSWB-13-11-2021-CSWB, dated 18-08-2022 of the Central Social Welfare Board, Ministry of Women and Child Development, Government of India, New Delhi. Subsequently, the Central Cabinet in its meeting held on 06-04-2023, has approved for closure of Central Social Welfare Board, as communicated *vide* F.No. CSWB-016/32/2021-CSWB (95239), dated 30-04-2023 of the Ministry of Women and Child Development, Government of India, New Delhi. No Grants-in-Aid, towards payment of salary to the staff, *etc.*, has been released by the Central Government from April 2023 onwards. It is also conveyed to ensure continuation of pension and other dues being disbursed to State Boards as 100% by the State Government/Union Territory Administration liabilities *vide* F.No. 93682/CSWB-13-11-2021-CSWB, dated 03-07-2023 of the Central Social Welfare Board, Ministry of Women and Child Development, Government of India, New Delhi.

2. And whereas, obtaining the views of the Department of Personnel and Administrative Reforms, the Finance Department, the Directorate of Accounts and Treasuries and the Law Department and necessary consent of the Governing Body of the Pondicherry Society for the Care of the Aged (PONCARE) and Indira Gandhi Medical College and Research Institute (IGMC&RI), Kathirkamam, Puducherry; a Policy decision has been taken by the Government of Puducherry for closure of the State Social Welfare Board, with immediate effect, by absorbing the existing 4 (four) numbers of staff of the Board into the PONCARE and the IGMC&RI *viz*; one Stenographer, one Upper Division Clerk and one Lower Division Clerk into the PONCARE and one Driver into the IGMC&RI and to continue the payment of Pension/Family Pension to 11 (eleven) Pensioners/Family pensioners of the State Social Welfare Board, Puducherry. Approval of Hon'ble Lieutenant-Governor of Puducherry has also been obtained for relaxation of age-limit and method of recruitment in the Recruitment Rules to enable to accommodate the 4 incumbents as stated in para 3, in the abovesaid Institutions. The services rendered by the staff in the State Social Welfare Board will be counted for all the purpose, except seniority, in the Departments into which they have been absorbed;

And whereas, the Administrator, State Social Welfare Board, Puducherry, is instructed to hand over all the belongings, *viz*; cash in hand, if any, the Bank deposits/Liabilities, if any, furniture/equipments along with stock register, vehicles, records, files, *etc.*, to the Social Welfare Department, Puducherry, by a detailed handing over report;

Now, therefore, the Hon'ble Lieutenant-Governor, Puducherry, is pleased to notify the closure of the State Social Welfare Board, Puducherry, by absorbing the existing 4 (four) numbers of the staff of the Board into the Pondicherry Society for the Care of the Aged (PONCARE) and Indira Gandhi Medical College and Research Institute (IGMC&RI), Kathirkamam, Puducherry, with immediate effect, and to continue the payment of Pension/Family Pension to Pensioners/Family Pensioners of the erstwhile State Social Welfare Board by the Government of Puducherry through Directorate of Accounts and Treasuries, Puducherry from April 2023 onwards.
