In exercise of powers conferred under sub-section (1) of section 14 of the Code of Criminal Procedure, 1973, (Central Act 2 of 1974) and in supersession of all the previous Notifications, dated 10-12-2015, issued on the subject, the Chief Judicial Magistrate, Puducherry, hereby authorizes the Fast Track Court at Magisterial Level at Puducherry, which is to be constituted as per G.O. Ms. No. 6/2020-LD., Law Department, dated 09-03-2020, to exercise the jurisdiction over the local limits over which, the Judicial Magistrate No. I to IV were hitherto exercising jurisdiction in respect of all criminal cases involving crimes against women which are triable by Judicial Magistrate with effect from the date on which the Judicial Magistrate (Mahila Court), Puducherry, assumes charge of that Court.
