#### PUDUCHERRY HOUSING BOARD, PUDUCHERRY

#### NOTIFICATION

In exercise of the powers conferred by sections 11 and 130 of the Puducherry Housing Board Act, 1973 (Act No. 7 of 1974) and with the prior approval of the Government, the Puducherry Housing Board, hereby makes the following rules regulating the method of recruitment to the posts in the Puducherry Housing Board, Puducherry:-

1. *Short title and commencement.*— (1) These rules may be called the Puducherry Housing Board Recruitment Rules, 2024.

(2) They shall come into force on and from the date of their publication in the Official Gazette.

2. *Application.*— These rules shall apply for recruitment to the posts in the Puducherry Housing Board, specified in column (1) of the Schedules hereby Annexed.

3. Number of post, its classification and Pay Band and Grade Pay/Pay Scale.— The number of the said posts, its classification and the Pay Band and Grade Pay/Pay Scale attached thereto, shall be as specified in columns (2) to (4) of the said Schedules.

4. *Method of recruitment, age-limit and other qualifications.*— The method of recruitment to the said posts, age-limit, qualifications and other matters relating thereto, shall be as specified in column (5) to (13) of the said Schedules.

5. Disqualifications.- No person, -

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Board of Puducherry Housing Board with the approval of the Lieutenant-Governor may, if satisfied, that such marriage is permissible under the Personal Law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

6. *Power to relax.*— Where, the Board of Puducherry Housing Board with the approval of the Lieutenant-Governor is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

7. Saving.— Nothing in these rules shall affect the reservations, relaxations in upper age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government from time to time in this regard.

*Note-2*: The Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

*Note-1*: The requirement of training for promotion is not applicable to the Officers holding the feeder post on regular basis on the date of notification of these rules.

*Note-2 :* Where, juniors who have completed their qualifying/ eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying/eligibility service by more than half of such qualifying/eligibility service or two years whichever is less and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying/eligibility service.

- (a) Officials working as Assistant or Upper Division Clerk with 5 years service in the grade rendered after appointment thereto on regular basis in Puducherry Administration; and
- (b) Possessing the educational qualifications prescribed for direct recruits under column (7).

*Note-1*: Period of deputation including the period of deputation in another *ex cadre* post held immediately preceding this appointment in the same or some other organizations or Departments of the Central/State/Union Territory Governments shall ordinarily not exceed 3 years. The maximum age-limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.
