2. Consent letter of Thiru B. Karthikeyan, 39A/32, Srinivasan Street, Thirupathiripuliyur, Cuddalore Taluk – Authorized Auctioneer, dated 18-07-2024.
3. Report of the Deputy Collector (Revenue) North, Puducherry *vide* Letter No. 3871 and 3942/DC(R)N/A7/PB/2024/2445, dated 19-09-2024.

Whereas, an application, dated 18-07-2024 was received from Thiru Nitesh Kumar Jain, son of Kailash Chand Jain, Pawn Broker (L.No. 622), No. 136, Lawspet Main Road, Puducherry-605 008, a licensed Pawn Broker requesting permission of the District Magistrate to sell unredeemed and time barred articles in public auction;

2. And whereas, the list of unredeemed are time barred articles submitted by the Pawn Broker was forwarded to the Deputy Collector (Revenue) North, Puducherry, for causing physical verification of the articles and ascertain that they remain unredeemed after the time allowed for redemption;

3. And whereas, the Deputy Collector (Revenue) North, Puducherry, has furnished the report *vide* reference (3) cited, stating that the Tahsildar, Taluk Office, Oulgaret, had conducted physical verification of the articles that are unredeemed and time barred pledged with Thiru Nitesh Kumar Jain, son of Kailash Chand Jain, Pawn Broker (L.No. 622), No. 136, Lawspet Main Road, Puducherry-605 008 and reported that the articles mentioned in the application remained unredeemed past the time allowed and the articles are kept in the licensed premises itself except the seventeen items *vide* Catalogue Nos. 3, 30, 31, 40, 42, 47, 70, 80, 84, 95, 96, 109, 113, 115, 116, 127 and 162 of the list, which were redeemed subsequently by the respective pawnners after the application of the Pawn Broker cited at reference (1);

4. And whereas, the rule 12 of the Puducherry Pawn Brokers Rules, 1966 prescribes detailed procedure on auctioning of pledges;

5. Now, therefore, Thiru B. Karthikeyan, Thirupathiripuliyur, Authorised Auctioneer, is permitted to conduct within 60 days from the date of receipt of this order, the sale of time barred and unredeemed pledged articles, as shown in the list enclosed and available with the Pawn Broker, Thiru Nitesh Kumar Jain, son of Kailash Chand Jain, Pawn Broker (L.No. 622), No. 136, Main Road Lawspet, Puducherry-605 008, in public auction in the licensed premises of the Pawn Broker at the above address, as per the list approved and sent to the Pawn Broker and the Auctioneer, except the seventeen items *vide* Catalogue Nos. 3, 30, 31, 40, 42, 47, 70, 80, 84, 95, 96, 109, 113, 115, 116, 127 and 162 of the list, which were redeemed. ## NOTIFICATION

Whereas, the Government is of the opinion that an industrial dispute has arisen between the management of M/s. Rajiv Gandhi College of Engineering and Technology, Puducherry and the Rajiv Gandhi Engineering College Thozhilalargal Sangam (Reg. No. 1516/RTU/2007) (Affiliated with CITU), over charter of demands in respect of wage revision, annual increment @ 10% and payment of *ex gratia* amount of ₹ 15,000 for the years 2021-22 and 2022-23, in respect of the matter mentioned in the Annexure to this order;

And whereas, in the opinion of the Government, it is necessary to refer the said dispute for adjudication;

Now, therefore, by virtue of the authority delegated *vide* G.O. Ms. No. 20/9/Lab./L, dated 23-05-1991, of the Labour Department, Puducherry, to exercise the powers conferred by clause (d) of sub-section (1) of section 10 of the Industrial Disputes Act, 1947 (Central Act XIV of 1947), it is hereby directed by the Secretary to Government (Labour) that the said dispute be referred to the Industrial Tribunal, Puducherry, for adjudication. The Industrial Tribunal, Puducherry, shall submit the Award within 3 months from the date of

issue of reference as stipulated under sub-section (2-A) of section 10 of the Industrial Disputes Act, 1947 and in accordance with rule 10-B of the Industrial Disputes (Central) Rules, 1957. The party raising the dispute shall file a statement of claim complete with relevant documents, list of reliance and witnesses to the Industrial Tribunal, Puducherry, within 15 days of the receipt of the order of reference and also forward a copy of such statement to each one of the opposite parties involved in the dispute.
